

1,323 payroll checks and direct deposits were issued in April.

In April, the year-end audit fieldwork was completed by Eide Bailly, LLC.

Year-end audit fieldwork included:

- Testing of selected accounts payable disbursements.
- Review of the Town's outstanding long term debt and compliance reporting.
- Review of the Capital Asset process and testing of selected additions and disposals.
- Review for accuracy of reported balances on Trial Balance including cash, capital assets, receivables, deferred revenues, payables and other liabilities.
- Review of revenue external confirmation letters against amounts reported in the General Ledger, including sharebacks, franchise fees and auto use tax.

The Accounting Division continues to work on compiling the 2014 Comprehensive Annual Financial Report. Edward has done an outstanding job in heading up this project, as well as Kim for pulling together all the statistical data.

After four months of testing and training, ExecuTime version 4 went live on April 22, 2015. Thank you Stacy, Caitlin and Kim for all your hard work!

Matt completed the CDOT High Visibility claim for reimbursement for the St. Patrick's Day period.

We have received some very positive feedback for Sarah and Angie on the "Partner in Accounting". Each department has one central contact in accounting now for AP, P-Cards, POs, and Capital Assets.

Accounting has been working closely with the Utilities department on the refunding of the Water and Sewer Revenue Bonds, Series 2006.

- Michael provided financial information to Accounting and Utilities pertaining to bond refunding




Grants

Jamie Authier completed and the Department of Justice, Bullet Proof Vest Grant application due on May 13th. Funds awarded from this grant are used to purchase protective bulletproof vests for the Town of Castle Rock Police Department. Since the Bulletproof Vests Program began, the Town has been awarded over \$44k towards the purchase of bulletproof vests. Vests are replaced every 5 years based on manufacturers recommended replacement schedule.

The financial report for January 2015 - March 2015 for the Vale Grant was submitted on April 29th to the District Attorney, 18th Judicial District. This grant is used for the Town's Victim Assistance Program which provides support 24 hours a day, seven days a week, to people who have been victimized by crime, traumatic experiences or suffered the loss of a loved one. The Town of Castle was awarded \$24,600 for the July 2014 - June 2015 grant term.

Reporting

- Sales tax revenue increased from \$3,033,526 in March* of 2014 to \$3,194,363 in March* of 2015
- That is up 5.3%
- YTD we are up 6.0%

Licensing

- We have licensed 45 businesses in April
- There have been 16 accounts closed in April
- Castle Rock currently has 3,503 active businesses licensed.
- 139 accounts left to renew. Phone calls are being made to remaining accounts for final collection.

Enforcement

- Sales Tax has collected \$48,062 in delinquency revenue for the Month of April
- \$136,164 YTD
- We currently have 22 audits in process with 8 more about to start in May
- \$1,616 in Audit Revenue for April 2015


