

TOWN OF CASTLE ROCK SERVICES AGREEMENT (2026 Funding Agreement)

PARTIES:	TOWN OF CASTLE ROCK , a Colorado municipal corporation, 100 N. Wilcox Street, Castle Rock, Colorado 80104 (the "Town").
	CASTLE ROCK SENIOR CENTER , a Colorado nonprofit corporation, 2323 N. Woodlands Boulevard, Castle Rock, Colorado 80104 (the "Senior Center").
RECITALS:	

The Town and the Senior Center agree to the below terms and conditions by which the Town will provide funding, and the Senior Center will utilize said funding, for the operation and provision of certain community services of the Senior Center as more fully described in the following Agreement and Exhibits.

TERMS:

- 1. **Scope of Services and Payment.** The Senior Center shall provide all of the services set forth below and as set forth in greater detail in the Senior Center's 2026 Proposal attached as **Exhibit 1** and incorporated herein ("Services"):
 - Fund operational cost of providing citizens age 50 ("Seniors") and above with A. educational, social, health, and recreation programs
 - B. Provide no/low-cost transportation to Seniors for medical appointments, shopping, and other destinations
 - C. Offer volunteer opportunities to keep Seniors active and involved in the community
 - D. The Senior Center will comply with the Agreement for Shared Facilities.

The Senior Center shall complete the Services consistent with standards and practices of the profession.

In no event shall the total payment to the Senior Center under this Agreement exceed \$170,000.00. Payments shall be made to the Senior Center on a quarterly basis in the amount of \$42,500.00, on or about March 15, June 15, September 15 and December 15. In the event that the Senior Center fails to perform or implement the above listed events or services, the Town may withhold payment for such event or service from the final quarterly payment.

Term. The term of this Agreement shall commence on January 1, 2026 and expire on December 31, 2026 (the "Term"). The Senior Center shall complete any Services in progress as of the expiration date. The Senior Center shall devote adequate resources to assure timely completion of the Services in accordance with the standards specified in this Agreement. The Senior Center shall perform the Services under this Agreement using a standard of care, skill and



diligence ordinarily used by reputable professionals performing under circumstances similar to those required by this Agreement.

- 3. <u>Termination.</u> The Town shall have the right to terminate this Agreement with or without cause at any time with ten (10) days' written notice to the Senior Center. Upon termination of the Agreement, the Senior Center shall have no claim against the Town as a result of the termination except for payment for Services completed up to and including the date of termination.
- 4. <u>Assignment.</u> This Agreement shall not be assigned by the Senior Center without the written consent of the Town.
- 5. Notice. Any notice required or permitted by this Agreement shall be in writing and shall be deemed to have been sufficiently given for all purposes if sent by certified mail or registered mail, postage and fees prepaid, addressed to the Party to whom such notice is to be given at the address set forth on the first page of this Agreement, or at such other address as has been previously furnished in writing to the other Party or Parties. Such notice shall be deemed given when deposited in the United States mail.
- 6. **Reporting.** The Senior Center shall submit in writing to the Town Manager a report on its activities no later than July 31, 2026, and shall also submit a written annual report for 2026 no later than January 31, 2027. Such reports shall include, but not be limited to, financial reporting and information on Senior Center achievements of 2026 performance objectives as outlined in *Exhibit 1*. The Parties agree the Senior Center's reporting obligations to the Town as set forth in this Section shall survive the expiration or termination of this Agreement.

7. **Insurance.**

General Conditions: The Senior Center agrees to secure, at or before the time of execution of this Agreement, the following insurance covering all operations, goods or services provided pursuant to this Agreement. The Senior Center shall keep the required insurance coverage in force at all times during the term of the Agreement, including any extension thereof, and during any warranty period. The required insurance shall be underwritten by an insurer licensed or authorized to do business in Colorado and rated by A.M. Best Company as "A-VII" or better. Each policy shall require notification to the Town in the event any of the required policies be canceled or non-renewed before the expiration date thereof. Such written notice shall be sent to the Parties identified in the Notices section of this Agreement. Such notice shall reference the Town. Said notice shall be sent thirty (30) days prior to such cancellation or non-renewal unless due to nonpayment of premiums for which notice shall be sent ten (10) days prior. If such written notice is unavailable from the insurer, The Senior Center shall provide written notice of cancellation, nonrenewal and any reduction in coverage to the Town by certified mail, return receipt requested within three (3) business days of such notice by its insurer(s). The Senior Center shall be responsible for the payment of any deductible or self-insured retention. The insurance coverages specified in this Agreement are the minimum requirements, and these requirements do not lessen or limit the liability of the Senior Center. The Senior Center shall maintain, at its own expense, any additional kinds or amounts of insurance that it may deem necessary to cover its obligations and liabilities under this Agreement. All commercial and automobile liability policies shall have the following additional provisions:



- Severability of interests or separation of insureds provision;
- Provision that coverage is primary and non-contributory with other coverage maintained by the Town;
- The underlying Agreement is an "insured contract" under the policy;
- Defense costs shall be outside the policy limits for liability coverage.
- B. **Proof of Insurance:** The Senior Center may not commence services or work relating to this Agreement prior to placement of coverages required under this Agreement. The Senior Center certifies that the certificate of insurance attached as *Exhibit 2*, preferably an ACORD form, complies with all insurance requirements of this Agreement. The Town's acceptance of a certificate of insurance or other proof of insurance that does not comply with all insurance requirements set forth in this Agreement shall not act as a waiver of The Senior Center's breach of this Agreement or of any of the Town's rights or remedies under this Agreement. Each certificate shall identify the Project and shall provide that coverage afforded under the policies shall not be cancelled, terminated or materially changed until at least 30 days prior written notice has been given to the Town. If the words "endeavor to" appear in the portion of the certificate addressing cancellation, those words shall be stricken from the certificate by the agent(s) completing the certificate. The Town may require additional proof of insurance, including but not limited to policies and endorsements.
- C. **Additional Insureds**: For Commercial General Liability and Automobile Liability, the Senior Center and subcontractor's insurer(s) shall include the Town, its elected and appointed officials, officers, employees, agents and volunteers acting within the course and scope of their duties for the Town as additional insured.
- D. **Waiver of Subrogation:** For all coverages required under this Agreement, The Senior Center's insurer shall waive subrogation rights against the Town, its elected and appointed officials, officers, employees, agents and volunteers acting within the course and scope of their duties for the Town.
- E. **Subcontractors:** The Senior Center shall confirm and document that all (including independent contractors, suppliers or other entities providing goods or services required by this Agreement) procure and maintain coverage as approved by the Senior Center and appropriate to their respective primary business risks considering the nature and scope of services provided.
- F. Workers' Compensation and Employer's Liability Insurance: The Senior Center shall maintain the coverage as required by statute for each work location and shall maintain Employer's Liability insurance with limits of \$100,000 per occurrence for each bodily injury claim, \$100,000 per occurrence for each bodily injury caused by disease claim, and \$500,000 aggregate for all bodily injuries caused by disease claims.
- G. **Commercial General Liability:** The Senior Center shall maintain a Commercial General Liability insurance policy with minimum limits of \$1,000,000 for each occurrence and \$2,000,000 products and completed operations aggregate, and \$2,000,000 general aggregate (per project). The policy shall provide coverage for all claims for bodily injury, property damage (including loss of use), products and completed operations, and contractual liability.



- H. **Automobile Liability:** The Senior Center shall maintain Automobile Liability with minimum limits of \$1,000,000 combined single limit applicable to all owned, hired and non-owned vehicles used in performing services under this Agreement.
- 8. No Waiver of Colorado Governmental Immunity Act. The Parties understand and agree that the Town is relying on, and does not waive or intend to waive by any provision of this Agreement, the monetary limitations or any other rights, immunities, and protections provided by the Colorado Governmental Immunity Act, §24-10-101, et seq., C.R.S., as from time to time amended, or otherwise available to Town, its officers, or its employees.
- 9. <u>Indemnification.</u> The Senior Center expressly agrees to indemnify, defend and hold harmless Town or any of its officers, agents or employees from any and all claims, damages, liability, or court awards including attorney's fees that are or may be awarded as a result of any loss, injury or damage sustained or claimed to have been sustained by anyone, including, but not limited to, any person, firm, partnership, or corporation, to the extent caused by the negligent acts, errors or omissions of the Senior Center or any of their employees or agents in performing Services pursuant to this Agreement. In the event that any such suit or action is brought against Town, Town will give notice within ten (10) days thereof to the Senior Center. These defense and indemnification obligations shall survive the expiration or termination of this Agreement.
- 10. <u>Delays.</u> Any delays in or failure of performance by any Party of the obligations under this Agreement shall be excused if such delays or failure are a result of acts of God, fires, floods, strikes, labor disputes, accidents, regulations or orders of civil or military authorities, shortages of labor or materials, or other causes, similar or dissimilar, which are beyond the control of such Party.
- 11. <u>Additional Documents; Entire Agreement; Severability.</u> The Parties agree to execute any additional documents or take any additional action that is necessary to carry out this Agreement. Further, this Agreement represents the entire agreement between the Parties and there are no oral or collateral agreements or understandings. This Agreement may be amended only by an instrument in writing signed by the Parties. If any other provision of this Agreement is held invalid or unenforceable, no other provision shall be affected by such holding, and all of the remaining provisions of this Agreement shall continue in full force and effect.
- 12. <u>Time of the Essence.</u> If any payment or any other condition, obligation, or duty is not timely made, tendered or performed by either Party, then this Agreement, at the option of the Party who is not in default, may be terminated by the non-defaulting Party, in which case, the non-defaulting Party may recover such damages as may be proper.
- 13. <u>Default and Remedies</u>. In the event either Party should default in performance of its obligations under this Agreement, and such default shall remain uncured for more than ten (10) days after notice of default is given to the defaulting Party, the non-defaulting Party shall be entitled to pursue any and all legal remedies (subject to the following limitations on damage) and recover its reasonable attorney's fees and costs in such legal action. No Party will be entitled to lost profits or incidental, consequential, punitive or exemplary damages in the event of a default.



- 14. <u>Waiver.</u> A waiver by any Party to this Agreement of the breach of any term or provision of this Agreement shall not operate or be construed as a waiver of any subsequent breach by either Party.
- 15. <u>Venue, Choice of Law and Disputes.</u> Venue for all legal actions shall lie in the District Court in and for the County of Douglas, State of Colorado, and shall be governed by the laws of the State of Colorado as well as the Charter and Municipal Code, rules, regulations, Executive Orders, and fiscal rules of the Town.
- Americans with Disabilities Act. The Senior Center agrees to ensure that any deliverables, work, services, or equipment developed, designed, constructed or produced pursuant to this Agreement, to include website design services, will comply with all requirements of the Colorado Anti-Discrimination Act, Title II of the Americans with Disabilities Act and, where applicable, Section 504 of the Rehabilitation Act and the Architectural Barriers Act. To the extent any deliverables, work, services, or equipment developed, designed, constructed or produced pursuant to this Agreement fail to comply with the requirements of this Section, the Senior Center shall indemnify the Town in accordance with the terms or this Agreement and, at the Town's option, shall re-vise, re-construct, or similar, the non-compliant deliverable, work, service, or equipment, or reimburse the Town for the cost associated with bringing the non-compliance deliverable, work, service or equipment into compliance.
- 17. <u>No Discrimination in Employment.</u> The Town is a governmental agency and, therefore, in connection with the performance of work or Services under this Agreement, the Senior Center shall not refuse to hire, discharge, promote or demote, or to discriminate in matters of compensation against any person otherwise qualified, solely because of race, color, religion, national origin, gender, age, military status, sexual orientation, gender identity or gender expression, marital status, or physical or mental disability, or any other protected class under Federal or State law; and the Senior Center shall insert the foregoing provision in any subcontracts hereunder.
- 18. <u>Title VI Compliance.</u> To the extent applicable, the Senior Center shall ensure its current and future compliance with Title VI of the Civil Rights Act of 1964, 42 U.S.C. § 2000d et seq., as amended, which prohibits the exclusion from participation, denial of the benefits of, or subjection to discrimination under programs and activities receiving federal financial assistance, of any person in the United States on the ground of race, color, or national origin.
- 19. <u>Digital Accessibility.</u> The Senior Center shall be responsible for ensuring that all deliverables, work, services, or equipment developed, designed, constructed or produced pursuant to this Agreement comply with Colorado law governing digital accessibility, including but not necessarily limited to at a minimum conforming with the current Web Content Accessibility Guidelines ("WCAG") followed by the State of Colorado. To the extent any deliverables, work, services, or equipment developed, designed, constructed or produced pursuant to this Agreement fail to comply with the requirements of this Section, the Senior Center releases, defends, indemnifies and holds harmless Town, its officers, agents, and employees from any and all claims, damages, suits, costs, expenses, liabilities actions or proceedings of any kind or nature whatsoever, of or by anyone whomsoever, in any way resulting from, or arising out of, directly or indirectly,



said failure. These defense and indemnification obligations shall survive the expiration or termination of this Agreement.

- 20. <u>Copyright.</u> The Senior Center warrants that all Services performed under this Agreement shall comply with all applicable patent, trademark and copyright laws, rules, regulations and codes of the United States. The Senior Center shall not utilize any protected patent, trademark or copyright in performance of the Services unless the Senior Center has obtained proper permission and all licenses, releases and other necessary documents. The Senior Center releases, defends, indemnifies and holds harmless the Town, its officers, agents, and employees from any and all claims, damages, suits, costs, expenses, liabilities, actions or proceedings of any kind or nature whatsoever, of or by anyone whomsoever, in any way resulting from, or arising out of, directly or indirectly, the performance of the Services under this Agreement which infringes upon any patent, trademark or copyright protected by law.
- 21. Open Records. The Senior Center acknowledges and understands that the Town is subject to the Colorado Open Records Act, C.R.S. § 24-72-201, et seq. ("CORA"). The Parties understand and agree that nothing in this Agreement shall restrict the Town from complying with CORA. Should the Town receive a request under CORA, the Town shall release copies of this Agreement and any other documents relevant to this Agreement to the extent that such records are subject to disclosure under CORA, or as otherwise required by subpoena, law, regulation, or court order.
- 22. <u>Authority.</u> The individuals executing this Agreement represent that they are expressly authorized to enter into this Agreement on behalf of the Town and the Senior Center and bind their respective entities. This Agreement is executed and made effective as provided above.
- Relationship of the Parties. This Agreement is not intended to and will not constitute, create, give rise to, or otherwise recognize a joint venture, partnership, or formal business association or organization of any kind between the Parties, and the rights and obligations of the Parties shall only be those expressly set forth in this Agreement. The Senior Center and the Town hereby represent that there is no employer-employee relationship between the Parties. The Agreement shall not be construed to create any employment relationship or contract for employment between the Parties. It is understood and agreed by and among the Parties that each Party's employees shall remain employees of that Party at all times and for all purposes, and for the sake of clarity, the Parties expressly acknowledge that it is not intended nor shall it be construed that any employee of the Senior Center is an employee of the Town for purposes of unemployment compensation, workers' compensation, or any other purpose whatsoever. The Senior Center is not covered by any worker's compensation insurance or any other insurance maintained by Town except as would apply to members of the general public. The Senior Center shall not create any indebtedness on behalf of the Town.
- 24. **No Third-Party Beneficiaries.** It is expressly understood and agreed that enforcement of the terms and conditions of this Agreement, and all rights of action relating to such enforcement, shall be strictly reserved to Town and the Senior Center, and nothing contained in this Agreement shall give or allow any such claim or right of action by any other third party on such Agreement. It is the express intention of the Parties that any person or entity other than Town



or the Senior Center receiving services or benefits under this Agreement shall be deemed to be an incidental beneficiary only.

- 25. <u>Counterparts & Electronic Signatures.</u> This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall be deemed to constitute one and the same instrument. Each of the Parties hereto shall be entitled to rely upon a counterpart of the instrument executed by the other Party and sent by electronic mail. Each Party agrees that this Agreement and any other documents to be delivered in connection herewith may be electronically signed, and that any electronic signatures appearing on this Agreement or such other documents are the same as handwritten signatures for the purposes of validity, enforceability, and admissibility.
- 26. <u>Licenses/Taxes.</u> The Senior Center affirms that it is in good standing with and is authorized to do business in the State of Colorado. Further, the Senior Center shall be solely responsible for paying all applicable taxes associated with or arising out of this Agreement.
- Confidentiality. The Senior Center agrees that it shall treat as confidential all information provided by the Town regarding the Town's business and operations. All confidential information provided by the Town hereto shall be used by the Senior Center solely for the purposes of rendering services or work pursuant to this Agreement and, except as may be required in carrying out the terms of this Agreement, shall not be disclosed to any third party without the prior consent of the Town. The foregoing shall not be applicable to any information that is publicly available when provided or which thereafter becomes publicly available or which is required to be disclosed by any regulatory authority in the lawful and appropriate exercise of its jurisdiction over a Party, any auditor of the Parties hereto, by judicial or administrative process or otherwise by applicable law or regulation.
- 28. <u>Priority of Provisions.</u> In the event that any terms of this Agreement and any Exhibit, attachment, or other referenced document are inconsistent, the following order of priority shall control: (1) this Agreement; (2) Exhibit containing Certificate of Insurance; and (3) Exhibit containing Proposal.
