

Currently Interested Customers



FIFTH STREET – UTILITIES PROJECT

DISCUSSION/DIRECTION

Benefits

- Good planning and helps with annexation of unincorporated property in Town
- Secure additional reusable water supplies
- Reduces cost of installing this infrastructure in the future
- Avoids future disruption of transportation system
- Provides opportunity to get existing community off of non-renewable groundwater
