## **RESOLUTION NO. 2024-**

## A RESOLUTION APPROVING THE EXECUTION OF THE FIRST AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT BETWEEN DOUGLAS COUNTY SCHOOL DISTRICT RE-1 AND THE TOWN OF CASTLE ROCK REGARDING THE SHARING OF COSTS FOR PROVIDING POLICE OFFICERS TO ACT AS SCHOOL RESOURCE OFFICERS

**WHEREAS**, the Town of Castle Rock, Colorado (the "Town"), by and through the Castle Rock Police Department (the "Department"), works with the Douglas County School District (the "District") to provide safe and secure environments for students, professional staff and visitors; and

**WHEREAS**, presently, the Town, pursuant to the Intergovernmental Agreement between Douglas County School District RE-1 and the Town of Castle Rock regarding the Sharing of Costs for Providing Police Officers to Act as School Resource Officers ("IGA"), provides six (6) full-time School Resource Officers ("SROs"); and

WHEREAS, dedicated SROs are assigned to Castle View High School, Castle Rock Middle School, and Mesa Middle School, two (2) SROs are assigned to cover the remaining fifteen (15) schools within the Town's boundaries, and one SRO is assigned as the dedicated sergeant to supervise the SRO team; and

**WHEREAS**, the District contributes funding to cover fifty percent (50%) of the total SRO program costs, with the exception of Aspen View Academy and World Compass Academy which independently and fully fund the SRO assigned to each respective school; and

**WHEREAS**, the District has requested the addition of two (2) SROs to the Department's SRO team, for which the District will fully fund the initial year of the additional two (2) SROs in the amount of \$541,775.54 to cover salaries, benefits, and startup costs; and

**WHEREAS**, the Town and District wish to amend the IGA to integrate the addition of two (2) SROs for the 2024-2025 school year, and the terms of the IGA will be evaluated for future amendments following the completion of the first year that incorporates the additional SROs.

## NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:

**Section 1.** <u>Approval</u>. The First Amendment to the Intergovernmental Agreement between the Town and the District is hereby approved in substantially the same form as presented at tonight's meeting, with such technical changes, additions, modifications, deletions, or amendments as the Town Manager may approve upon consultation with the Town Attorney. The Mayor and other proper Town officials are hereby authorized to execute the Agreement and any technical amendments thereto by and on behalf of the Town.
