Craig and Gould's Addition to Castle Rock for Use as a Day Care Center [399 North Gilbert Street]

Development Services Director Bill Detweiler gave an overview of the item. The property is currently zoned R-2 and was used as offices, a day care and library in the past. Improvements are planned in the interior and exterior. Neighborhood input resulted in additional screening and fencing around the outdoor play area. Planning Commission and staff feel it meets the 2030 Comprehensive Master Plan and Municipal Code and recommend approval.

[RES 2018-096](#) **Resolution Approving the First Amendment to Epiphany Evangelical Lutheran Church of Castle Rock Annexation and Development Agreement [located at 550 Wolfensberger Road East]**

Development Services Director Bill Detweiler stated this is a development agreement the Council previously approved. The property was annexed in 2009 for church use. The church is requesting an extension of the agreement to keep the modular units in place until December 31, 2021. Staff recommends approval of the development agreement amendment. The applicant is present for any questions.

Citizens that addressed Town Council:

Pastor Chris Mathis stated he is the applicant and yields his time.

Curtis Williams is a member of the church and stated President Larry Martin, Gary Fuller who leads ministry and other members are present. Fuller has lived in Castle Rock for 25 years. In 2016 they realized the agreement was ending in 2018; and during that time he and his family faced many health issues and was not able to do the fundraising necessary to raise money to build other buildings. Their organization ships clothing to orphanages around the world and are a non-profit Christian organization.

Councilmember Loban extended his appreciation for organizations like this in our community that reflect positively on Castle Rock.

Bower moved, seconded by Loban, that Resolution No. 2018-096 be Approved as presented. The motion passed by the following vote:

[DIR 2018-044](#) **Discussion/Direction: Solaray Pugs (SRP) Incentive Request**

Frank Gray the CEO of Castle Rock EDC gave a presentation on Solaray Pugs gear who merged in 2016 and would like to expand in Castle Rock. We originally gave an economic incentive agreement to them and they have grown and now provide high paying salaries. They anticipate organic growth as well as relocation. They are competing for them to come to Castle Rock. They would like to keep their business in Castle Rock and are requesting \$300,000 for primary job creation of 30-40 employees at \$7,500 per job with no permit and fees attached to the incentive. We are asking them to commit to a long-term commitment with a 5 year lease, purchase a building, or build and expand in Castle Rock within 18 months. Economic Impact analysis estimates \$57.3M annually in economic impact and helping us to reach the goal of more high paying jobs in Castle Rock.

Councilmember Bower clarified that the Town will collect all the permits and fees.

Loban moved, seconded by Teal, to direct staff to prepare an agreement to bring back to Council for consideration. The motion passed by the following vote:

Town Manager David Corliss reminded Council that Council requested staff to investigate further options and to take action to formally recognize the Crystal Valley Coalition. Councilmember Teal and Loban will be liaisons to the Coalition.

Councilmember Bower asked if this is like a steering committee. Corliss replied that it is stakeholders that we will keep apprised of funding options. Council will make the decisions how to fund it, the Town's participation, timing, etc.

Councilmember Teal stated it became apparent that a coalition was needed to hear from all of the interests in the area.

[ORD 2018-039](#) **Ordinance Approving Supplemental Appropriations for 2018 and the Second Amendment to the 2018 Budget (First Reading)**

Matt Gohl from Finance gave an overview of the budget amendment. \$13.2M are one-time requests mainly made up of Water-related requests, \$1M in Parks and

Recreation projects, \$1M for remediation of 830 North Wilcox Street and \$150k for the Plum Creek Parkway widening design costs. Two operational amendments of \$202k are related to healthcare claims and pro shop merchandise expenditures which includes offsetting revenue.

Councilmember Bower asked to clarify the funds needed to purchase merchandise. They expended their budget authority so this is to give them the authority to spend the funds they have on merchandise.

Councilmember Teal was happy to see Metzler Ranch baseball field replacement with artificial turf.

Teal moved, seconded by Green, that Ordinance No. 2018-039 be Approved on First Reading as presented. The motion passed by the following vote:

[RES 2018-098](#) **Resolution Approving the Castle Rock Downtown Development Authority Proposed Annual Budget for 2019**

Director of the Castle Rock Downtown Alliance Kevin Tilson is here on behalf of the Downtown Development Authority to present their budget. Once approved by Town Council, it is formally adopted by the DDA proposed for December 6. The first goal is to focus on development in the downtown core with retail, office, and residential; and second to develop Festival Park. In 2019 they will continue to focus on development in the downtown core, facade improvements, outdoor patio program, flowerboxes, downtown events, and operating the ice skating rink. They anticipate receiving \$165,000 from the 3 mill mill levy and a rise in income from the Rink at the Rock due to higher attendance and slight increase in fees.

[RES 2018-099](#) **Resolution Approving the Town of Castle Rock Construction Contract with Hudick Excavating, Inc. for the Construction of the East Plum Creek Trail Phase 5**

Director of Parks and Recreation Jeff Brauer stated they are planning on extending the trail to the south from South Perry Street to Crystal Valley Parkway. They plan to start construction in late 2018 and complete by September of 2019. GOCO awarded the Town a \$1M grant which is reimbursed to us after expenditures. They received 11 bids and chose Hudick as the lowest bidder. They added alternates for a soft surface trail adjacent to the paved trail that is about 1/4 mile long and two years of landscape maintenance including watering the trees for an

additional \$26,480 for a total contract of \$2,103,307.

Councilmember Brett Ford arrived at 7:25 pm.

Councilmember Teal asked to clarify the soft surface trail. Brauer said that this is a spur trail to the overlook. Brauer said they do have a 404 permit and will begin work that is not within the flood area until the map revision is done which they anticipate in January.

No public comment.

Loban moved, seconded by Teal, that Resolution No. 2018-099 be Approved as presented. The motion passed by the following vote:

[RES 2018-100](#) Resolution Approving a Construction Contract with Applied Ingenuity LCC for the Denver Basin Wells Rehabilitation and Pumping Equipment Replacement Project

Castle Rock Water Director Mark Marlowe stated they have an annual preventative maintenance program. They received a 65% increase in productivity after rehabilitation of the last wells they worked on. They selected Applied Ingenuity to rehab wells that have been identified with declines in production. The Water Commission and staff recommend approval.
