PERCEPTUAL CARNIVAL Spring Break Activity FREE March 25 Event Space, Phillip S. Miller Library The eye is the window to the soul. It is also the road to academic success for kids. Add ears to that equation and you have a Spring Break event. Kids will think they are playing games, doing activities, eating carnival food, winning prizes, and having fun. Grownups will actually be checking out vision and hearing acuity as well the need for vision therapy, auditory therapy, or speech therapy. A child can have 20/20 vision and still need vision therapy to succeed in school. Often misdiagnosed as ADHD or other disorders and treated with hard-core drugs, the need for vision therapy is not about visual acuity but how the eyes and brain work together. A child may not need a hearing aid yet have trouble processing what he or she hears, thus the need for auditory therapy. And what about a preschooler's cute little lisp? Will they outgrow it or need follow up? Parents know very little about these types of therapies which can make all the difference for a child and schools typically do not offer these therapies. This program will be an opportunity to educate parents as well as to spot problems early in a child's life. The earlier a disorder is addressed, the better the outcome, especially with a perceptual disorder like Amblyopia.. The Douglas County Parenting Coalition will be partnering with Children's Advisory Network and CU-Health to put on this event at which we expect 300 or so parents and children to attend. The program and services will be FREE for all residents. We will match the Castle Rock Community Grant with

Therapist \$1,000 Childrens Advisory Network, testing \$500 M.D. Specialist from CU Health, Lone Tree The current cash match is \$200 from the DCPC operating budget and we hope to get some additional donations from local businesses to buy "carnival" prizes for kids. The Castle Rock Community Grant money would be used to buy carnival type food for the kids, entertainers, and small prizes--the testing activities will be presented to kids like carnival games to make them fun. The entertainment and food will keep them from getting bored while they are waiting to be tested.
