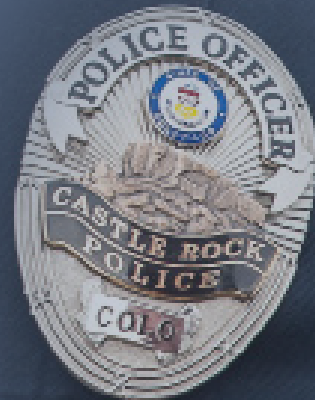

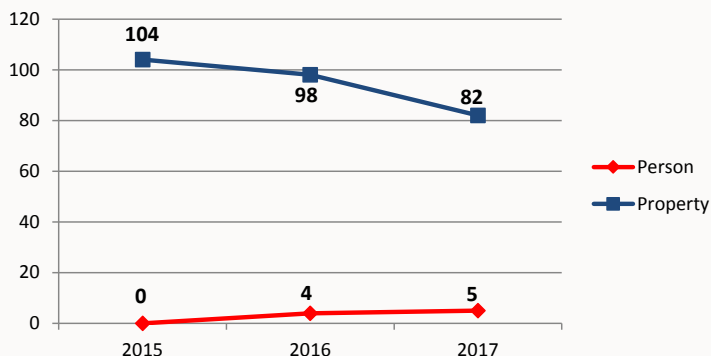

FROM THE DESK OF THE CRIME ANALYST

BE WARY OF THE Wi-Fi

Nowadays, people seem to be attached to their phones at all times, making Wi-Fi an almost essential part of our lives. But, do you know how criminals utilize Wi-Fi to obtain information? Here are a few tips as to how you can prevent yourself from being a victim of these particular types of criminals:

1. Ensure that the Wi-Fi network is authenticated. Know the exact name of the establishment's network that you are using, as criminals may set up "free" networks to fool you in hopes that you will use them and login to sites using your own usernames and passwords.
2. Don't use or download apps that require personal information while using public Wi-Fi, as others can access the Wi-Fi network in an attempt to obtain your information.
3. Never send personal information to unencrypted websites. Also, avoid doing mobile banking on public Wi-Fi networks, as you cannot verify the security of the network or who else is using it.
4. If you must log in to a personal account, make sure that you log off as soon as you are finished to prevent others from logging in.

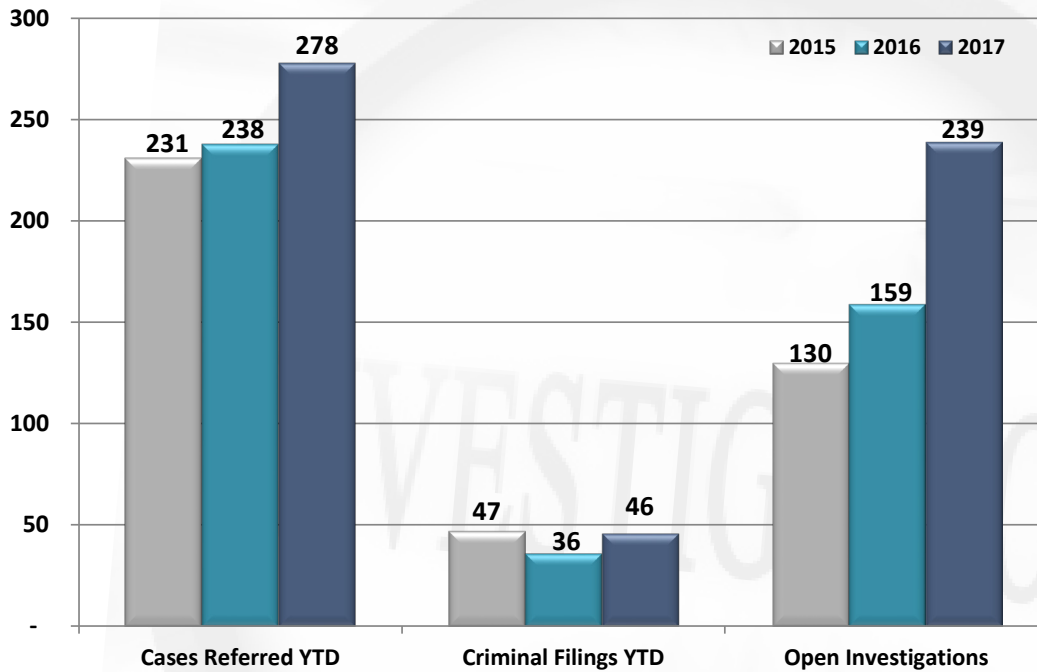

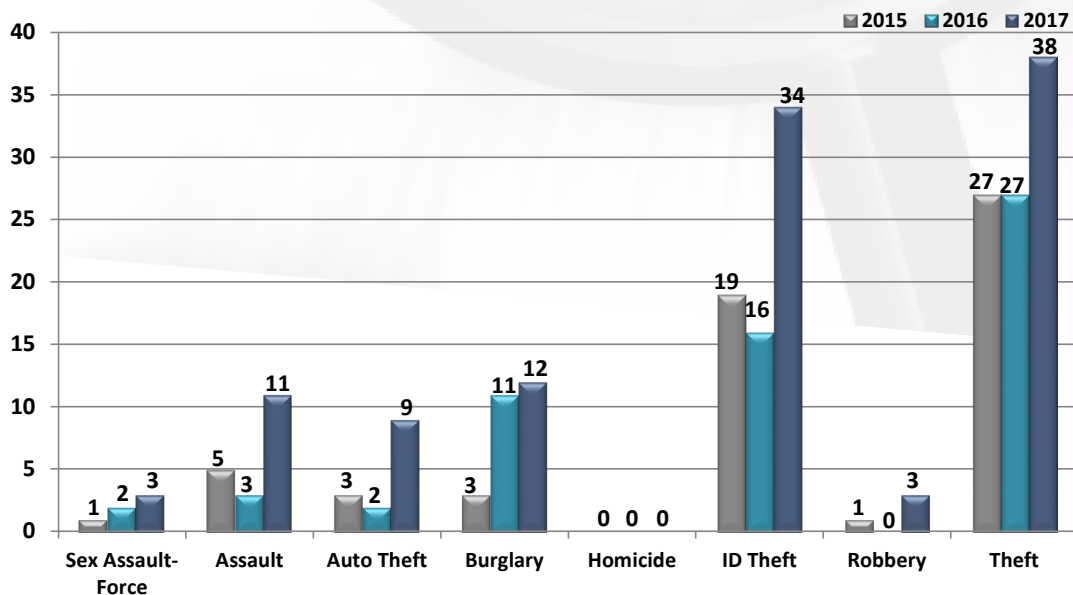

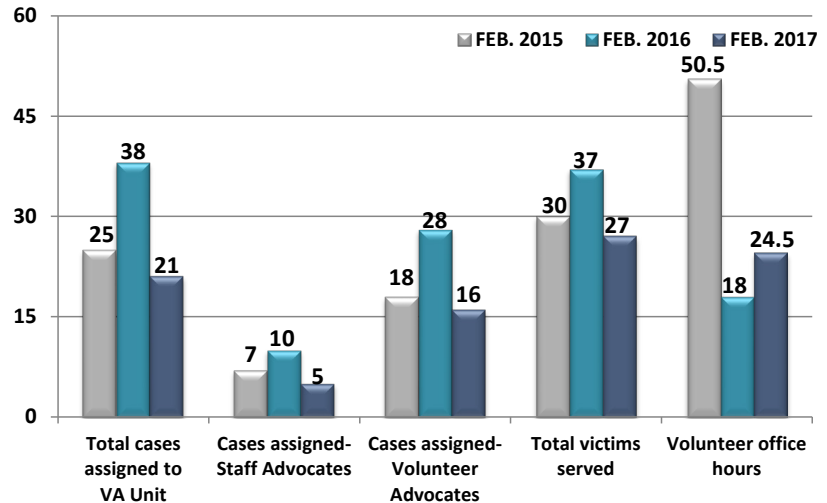

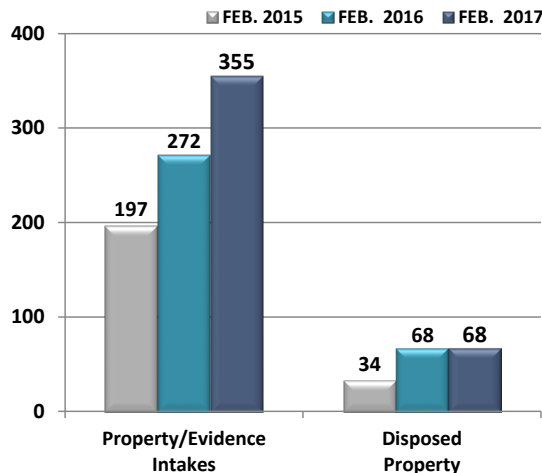
Debbie has a master's degree in social work from the University of Denver. Debbie recently joined our team after completing a 40-hour training academy for law enforcement advocates.

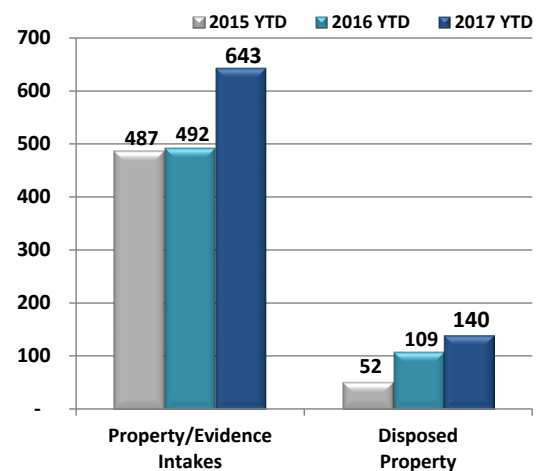


PROPERTY & EVIDENCE STATISTICS

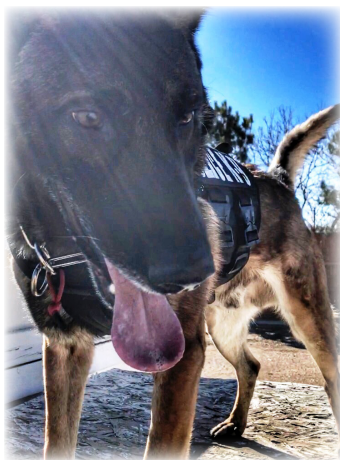
Notes of interest:

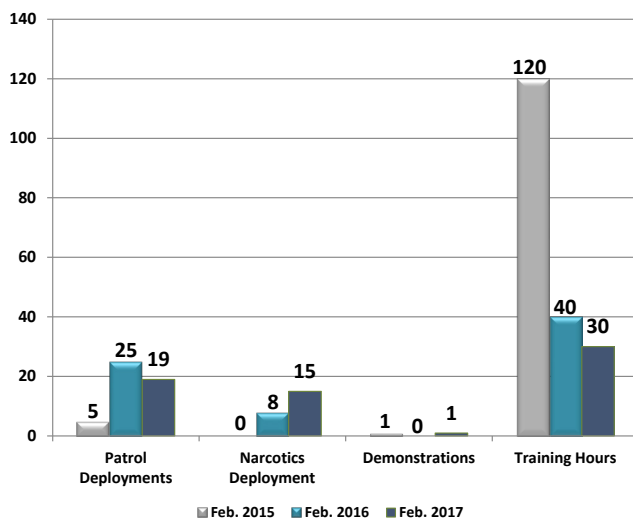

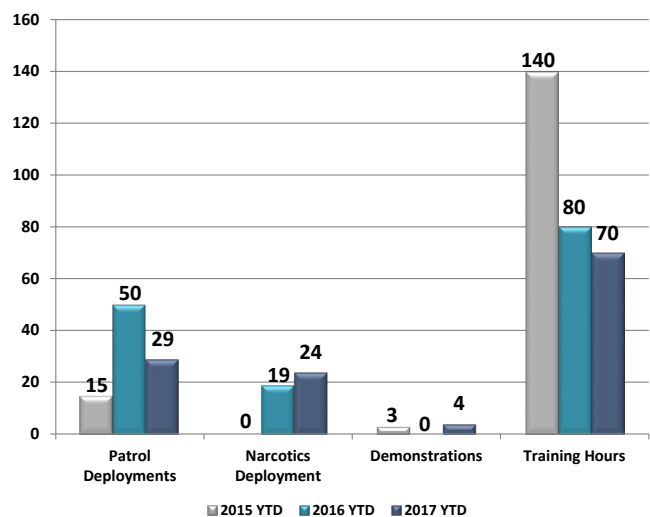

YEAR-TO-DATE COMPARISON FEBRUARY (2015-2017)



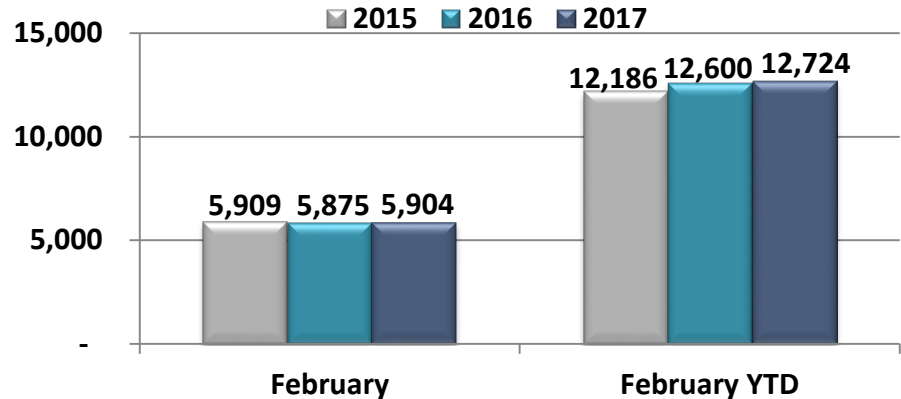


CALLS FOR SERVICE FEBRUARY (2015-2017)

EXPLORER UNIT FEBRUARY 2015-2017

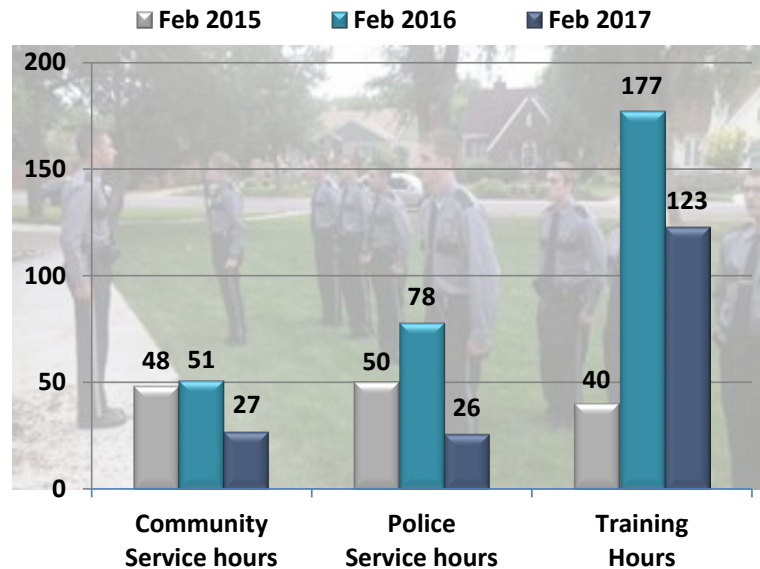
There were no Explorer events held during the month of February.

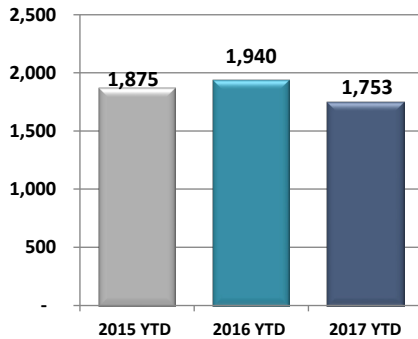

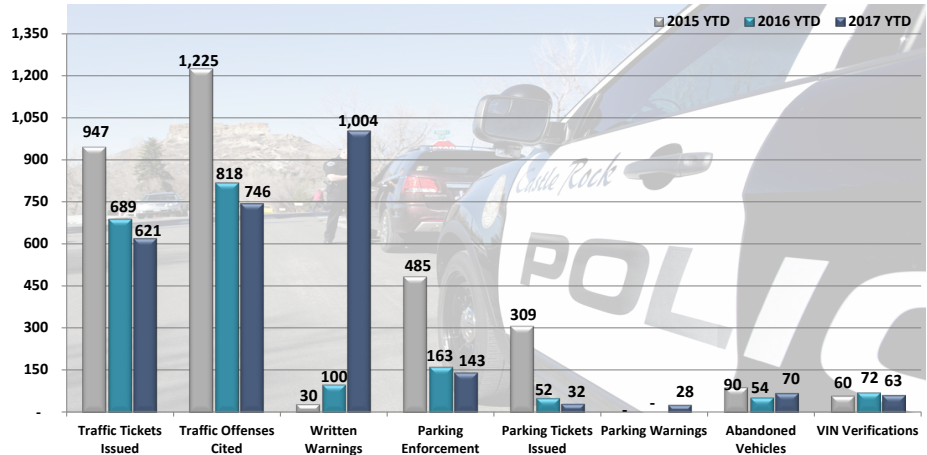
TOTAL TRAFFIC STOPS

On February 16 the Castle Rock Police Department participated in Operation Move Over.

Twenty-six law enforcement agencies joined together on February 16, 2017 to enforce the Move Over law and educate drivers of its importance. We reported the following stats as a follow-up to the efforts from February 16:

- Total Stops by participating agencies: 909
- Move Over Violations: 585 (194 Citations/391 Warnings)
- Driving Under Restraint: 6
- DUID: 1
- Highest Speeds: 123 mph and 106 mph

IT'S THE LAW

The "Move Over" law is in place to protect law enforcement, safety crews, and other roadside workers as they work to keep drivers safe. When there is an emergency vehicle on the side of the highway or road, the law requires drivers to move over one lane away from the safety vehicle to provide a safe buffer for its occupant(s). If the stop is on a one lane road or traffic doesn't allow, then drivers must greatly reduce their speed when approaching the emergency vehicle.

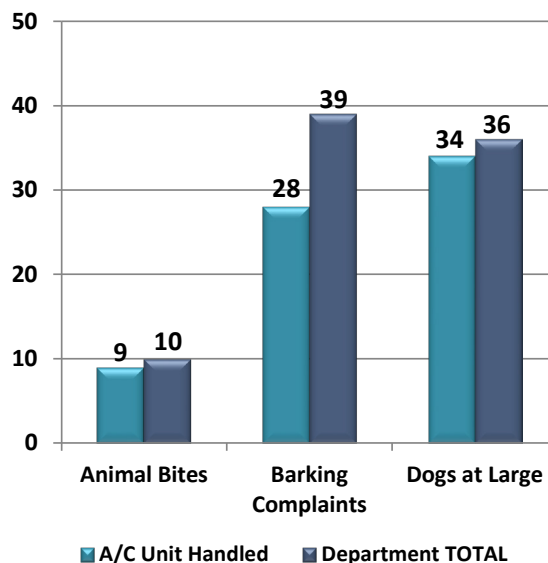
While the "Move Over" law has been State law for some time, sadly, several officers have been injured or have lost their lives due to motorists not abiding by the law. Therefore, law enforcement agencies across the state of Colorado have and will continue to join forces in educating drivers and enforcing this lifesaving law, which not only makes it safer for safety personnel, but also for all motorists.

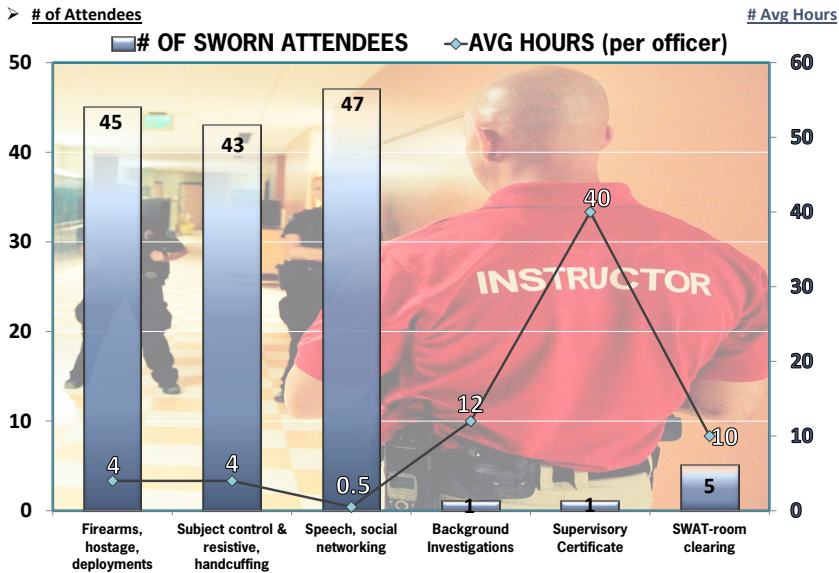

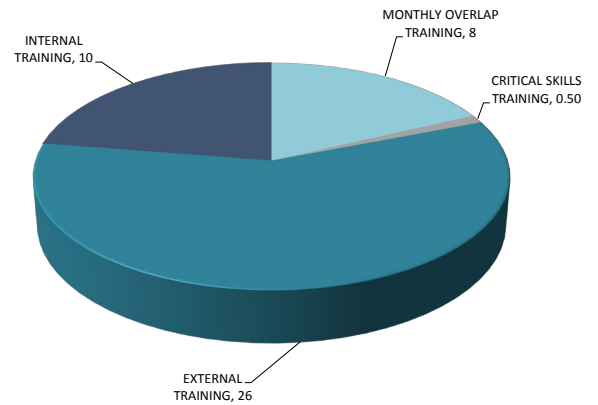

FEBRUARY 2017

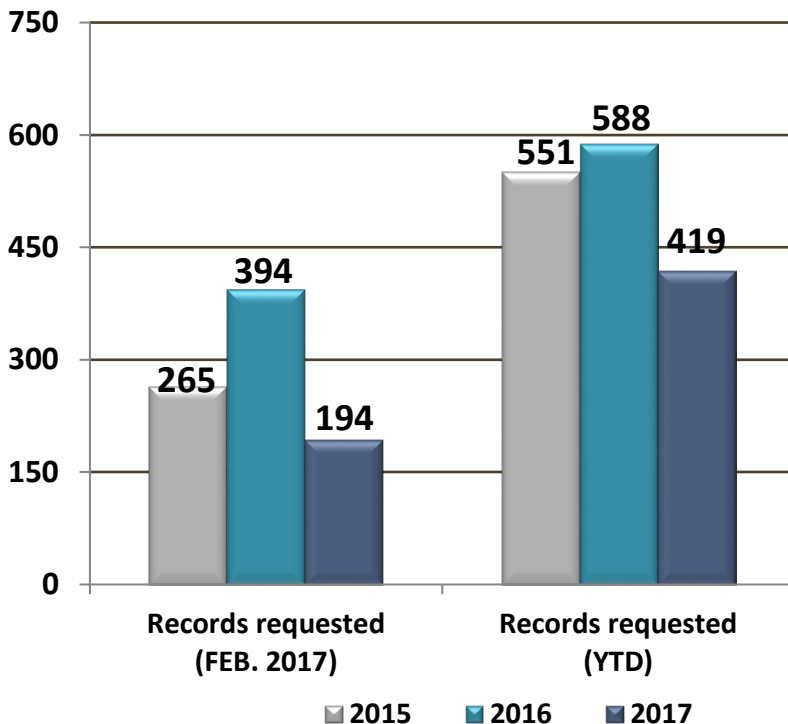


TRAINING HOURS BY CATEGORY

FEBRUARY 2017

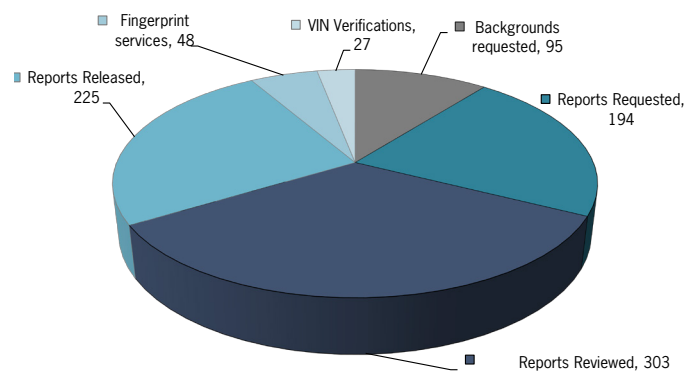


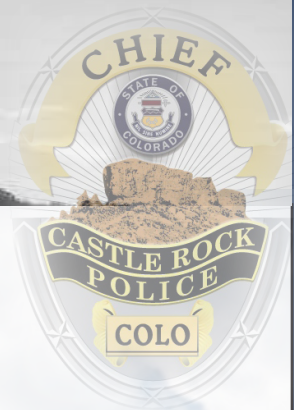
