Operations Division:

Deputy Chief Commentary:

September featured research and trials of some technology upgrades and improvements that could come over the next few months. We've begun preparing for the impending move to the new NERIS fire reporting system, and our on-boarding is planned for November with a complete move at the first of the year. The ImageTrend report will look very similar to what is used now but with different and updated data fields. We also investigated a promising new visual pre-planning piece to ImageTrend that automatically incorporates all the permits, inspections, and information that the FLSD obtains. This would replace First Due, but we won't do any move until the software is capable of a few more features (ex: automatic GIS updates). The EMS Leadership Team started looking into a potential purchase of Hand-Tevy, and more research is being led by FF Mitch Murphy. Lastly, we have begun demoing the AI integrations for our ImageTrend ePCRs, and they look good so far. These features include voice-to-narrative and being able to take a photo and have information auto-import to the report (ex: face sheets, driver's licenses, medication lists).

EMS: Following the news that Dr. Luyten will not be continuing as our Medical Director, we began meeting with potential candidates in the CarePoint group. Those initial interviews will conclude in October, and any recommended candidates will then spend time with the EMS Leadership Team before a final decision is made on the future of our medical direction. The EMS Leadership Team also recommended creating a shift lead position, which was subsequently implemented to help streamline EMS related communications to each shift, assist in delivering CQI feedback, and to serve as a main point of contact for each shift's EMS needs. The EMS Working Group has submitted the updated BLS Attending SOG and Agency Guideline for review, and those documents will be the foundation for the revised program. Lastly, thank you to FF Kyle Flores for teaching this month's EMS training!

Special Operations: The Wildland Team is back in California, assisting in the northern part of the state with initial attack operations. Training was a big focus this month, with crews participating in a joint training with SMFR on white powder scenarios, several members obtaining their HM-Tech certs (congrats FFs Nolan Devine and Jamie Miller), and LT Troy Robberson attended a specialist level trench course in Michigan – and he will share what he learned in upcoming trainings for the team. Planning is underway for our CRFD Extrication Technician Course, and members attended a regional training planning meeting with SMFR and WMFR. We also purchased a remote anchor picket for the squad, which replaces using equipment not designed for this function. Finally, an audit is underway for the squad, collapse, and hazmat units that will help us identify gaps in our equipment needs.

Pipes and Drums: The band was busy in September, playing at the CRPFF golf tournament, the LODD funeral service for CSFD Engineer (ret) Patrick Rogaki, the Douglas County Hero's Gala, the North Area Fire Academy graduation, the Brotherhood for the Fallen golf tournament, and the annual IAFF Fallen Firefighters Memorial.

Apparatus: We are working on some issues with the Brush truck slated for Station 156, receiving two new medic units (anticipated in October), and the current build for Engine 156 (anticipated in early 2026).

Call Statistics:

For September, we responded to 627 calls for service. For the year, we have now responded to 5,425 calls, which is 145 more than at the same point in 2024. We averaged 21 calls per day for the month.

Of the 627 calls this month, 8 were fire-related, 30 were motor vehicle crashes, 71 were service in nature, 376 were EMS calls, 66 were good intent calls, 55 were alarms, and the remaining were miscellaneous. In September, we transported 318 patients to area hospitals, with 254 transported to Castle Rock, 47 to Sky Ridge, and 17 to other facilities.

Administration Division:

Fire Chief Norris Croom

Key Admin Issues:

Congratulations to Sr. EVT Ben Jennings on earning the 2nd Place Award in the EVT of the Year program sponsored by Spartan and Firehouse Magazine. Ben was selected from twenty-three nominees nationwide, and is recognized for his excellence, dedication, and service in all aspects of our fleet section of the Logistics Division. Congratulations Ben!

Interviews were held for the Division Chief vacancies in the Fire and Life Safety Division as well as Logistics in late September. CPS, a well-known, national recruiter that has a significant amount of experience in fire service recruiting and hiring, managed the process of interviewing 4 candidates for Fire Marshal and 6 candidates for Logistics. Members from each division (as well as others) participated in the interview process, and made their recommendations. Chief's interviews were completed at the end of the month, and offers will be made to a candidate for each position. We hope to be able to announce our new chiefs in October.

The admin remodel started in August, continued through September, and should be finalized in October. This is being done to better utilize our space at admin with the addition of new positions and to be able to accommodate additional positions in the future. While the remodel is substantially done, we still have some painting, moving or installation of equipment, and then overall cleaning before we will be complete.

A local contractor began work on wildland mitigation on 7.2 acres of Centennial Park. This area was identified in the CWPP as a "Very High" risk, and we have finally been able to work to reduce the risk. It should take about two weeks to complete, and it was the subject of a Fox31 story on mitigation.

Fire Chief Commentary:

Members participated in the Douglas County Community Foundation Heroes Gala on September 12. Crews answered questions and showed off Hazmat 153 as part of the static display, and members of our Pipes and Drums performed as part of the Colorado Emerald Society Pipes and Drums for the event. This is the third year that we have participated at the request of the Foundation.

The department hosted "Rescue Night" as part of the Your Town Academy program. After having hot dogs and hamburgers cooked by our own Lt. Roan, attendees were given a brief overview of the department and a medic unit, and then conducted hands on training with crews on auto extrication, hose line management, and hands only CPR. The reviews from the attendees were very positive, and they appreciated all of our crews' efforts with them for the evening.

Design work is almost done for Station 156 and Logistics, and we have finalized a detailed budget of almost \$21 million. We still need to complete a replat of the site and are working with the

architect, surveyor, and Town to make this happen. A Pre- Application meeting is scheduled for early October where the Town will advise of any concern or issues. Once this meeting is complete, we will begin the process to submit formal plans for review to begin the construction process. We will have at least one neighborhood meeting in the near future, will be putting up a "future home" sign on the site, and work to get Council approval on the first phase of the project to begin dirt work. Stay tuned!

Congratulations to all of our members who were recognized at the Town's annual Years of Service event! From 5 to 30 years (Lt. Johnson), I received a number of comments about how many people we have who have been here more than 20 years. It is a testament to their commitment to the department and the Town.

Finally, BC Morgenthaler, Lt. Helle, Eng. O'Brien, FF/PM Crewse, and I dressed up and sang a modified version of Abba's "SOS" for the Mayor's State of the Town video. While not the best singers, we did generate a number of smiles and laughs when the video was shown at the State of the Town. Last year Ted Lasso, this year musicals. What will next year bring?



Fire and Life Safety Division:

Acting Fire Marshal Kevin Sullivan

<u>Fire and Life Safety Division Summary:</u> Personnel Highlights

In September, the Fire and Life Safety Division welcomed a new team member, Paul Harris. Paul brings extensive experience as an inspector from the Town of Parker, along with 20 years of firefighting experience in Illinois. We are excited to have him join our team.

Inspection and Plan Review Activity

In September, the Fire and Life Safety Division continued to support Castle Rock's growing community through inspections, plan reviews, public education and strategic community risk reduction efforts. A total of 243 inspections were completed, including 80 construction inspections, 154 business inspections, 4 mobile food vendor inspections and 5 special event inspections. On the development side, staff conducted 99 plan reviews, which included 72 development services reviews, 26 fire protection system-specific reviews and 5 special event plan reviews.

Code Compliance and Enforcement



Life Safety Education

For the month of September, CRFD made contact with

- 234 people through 11 different public education and community events totaling 7.5 hours of education. Of the citizens we made contact with in September, 150 were children (18 years of age or younger) and 84 were adults.
- 15,104 digital contacts were made during the month as well.

Car Seat Education

Crews and FLSEs assisted with community education for 40 car seat checks this month. The car seat checks were comprised of 37 rear-facing seats and 3 forward-facing seats.

- Car Seat techs identified and resolved 8 different installation errors.
- Car Seat checks performed through scheduled appointments: 9

Community Engagement

- PulsePoint: During August 2025 (reporting is one month in arrears,) 2,063 users following CRFD on the PulsePoint app enabled CPR alerts, and there were 7,202 Monthly Active Users. MAUs represent individuals actively following CRFD on the app during the reported month.
- **Social Media:** During the month of August (reporting is one month in arrears), the CRFD Facebook page reached 105,453 people. Posts were shared 66 times during the month, and post engagements came in at 1,314. Our three highest reaching posts were about the fire at Castle Rock Elementary school, and two regarding the wildfire deployment.

Training Division:

Division Chief Jeff Hood

Division Commentary and Happenings: September was a busy month for the Training Division, with 2,051 training hours logged across the department. Much of the work focused on delivering new department wide training opportunities, refining promotional processes, and continuing to plan for major initiatives scheduled for later this year and into 2026.



Strategic Planning and Initiatives: The Training Division continued to advance long-term projects, including preparations for the Acting Lieutenant process, development of the 2026 Acting Engineer class, planning for the Transition Academy scheduled after the recruits graduate in December, and quarterly incident command training.

Hoarder House Training: Department-wide hoarder drills were conducted for the first time, providing crews with a unique opportunity to train in realistic, cluttered environments. Tower rooms were converted into hoarder scenarios that required crews to ventilate, enter, and search—skills that are increasingly important given the hazards these conditions present in our community.

DEA Clandestine Lab Training: The CRFD hosted the United States Drug Enforcement Administration for training on clandestine lab identification and entry. HazMat members attended both classroom and practical portions, with both agencies identifying strong crossover potential for future joint training in Castle Rock.

Chameleon Gymnastics Training: Northern CRFD companies are training at Chameleon Gymnastics to practice patient removal from foam pits, simulating neck or back injuries. This unique training addressed a low-frequency, high-risk scenario and gave crews valuable experience in a unique environment.

Power Line Safety Training: Department-wide power line and transformer safety training was provided by CORE Electric. Using live props and visuals, crews were refreshed on operations and reinforced best practices for safely operating around energized equipment.

Enhancing Station Training Props: Station 154 will be provided with a continuous extrication car for company drills. We assisted with continued progress on repairs to the HazMat trailer at Station 153, and the rope/technical rescue prop at Station 155 continued to be built out and refined.

Other Division Happenings:

- Your Town Academy rotated its students to CRFD for a fire service introduction and hands-on training experience
- Initial planning began to host retired FDNY Captain Mike Dugan in Castle Rock for a department-wide event at the conclusion of the Transition Academy
- Work continued with CPS to prepare for the October Lieutenant promotional process
- Progress continued with RestoPros to build new burn cells for future live fire training
- The Training Division continued to oversee CRFD recruits at West Metro Academy and monitor their progress
- Worked with the Assistant Chief of EMS and Special Operations to prepare the Extrication Team for October's technician-level training

The Commission on Fire Accreditation International (CFAI) has officially released the latest edition of the Fire and Emergency Services Self-Assessment Model (FESSAM). This model is regularly updated to reflect current trends and evolving standards within the fire and




emergency services industry. The CRFD is proud to be among the first agencies to undergo the accreditation process under these newly established guidelines when we appear before the Commission in 2027.

The current FESSAM (11th Edition) includes 250 individual performance indicators designed to assess an agency's compliance across all areas of operation. These indicators are organized into eleven distinct categories, each addressing specific criteria. Through the accreditation process, agencies are required to thoroughly describe and evaluate every aspect of their organization. When gaps are identified, a structured improvement plan is developed. All performance measurements are supported by current and relevant reference materials.

September was busier than usual; in fact, this marks the highest number of calls for service recorded in any September over the past five years.





Total Priority 1 calls





Community Response Team: Calls for service







Customer survey results

Mr. Dziubla moved to approve the September 4, 2025 minutes. Mr. Morton seconded the motion; the motion carried.

Fire Department Report

CRFD August Report

- Commission members were emailed a copy of the Fire and Police Department's August report prior to today's meeting.
- Brush 155 and crew are on their way back to Castle Rock after completing a wildland deployment in California.
- Interviews were held last week for the two division chief vacancies. Offer letters will be extended next week.
- The State of the Town has been posted on YouTube.
- The first reading of the 2026 budget is scheduled to be presented to Council on October 7. The second reading is scheduled for October 21.
- Chief Croom gave commission members a handout of the project narrative for Station 156. Total cost of the project is \$21 million. Chief Croom gave a brief explanation of the financing for the project. Chief Croom was then asked how the location of Station 156 was selected - the location is determined by call volume, distance and response times.
- Chief Croom was asked if the logistics portion of Station 156 was designed to accommodate future growth - Chief Croom answered yes, and then spoke about the station design.
- The purchase request for two replacement fire engines has been placed on the Council agenda for October 21. Currently, there is a 50-month lead time for new orders. Each engine will cost 1.3 million. If the Town pre-pays, we can receive a \$380,000 discount.
- Chief Croom was asked what is terradaptor equipment Chief Croom explained that it is a tool used for high and low angle rescues.

Police Department Report

CRPD August Report

- Commission members were emailed a copy of the Police Department's August report prior to today's meeting.
- The First Responder drones are now operating full time. They are launched off the O&M building and have great response times. The department has been getting a great deal of use from the drones.
- The department is in the middle of its final phase of the current hiring process and has a healthy candidate pool. There are 12 people moving forward in the process.
- The department is also getting ready for its upcoming promotional process. This will include two commander spots (one existing and one new) plus a Deputy Chief position. Commander Varela was then asked the number of commander positions in the department - Commander Varela responded that there are five commander positions within the department.
- It was asked if revenue from 2A is reaching projected amounts. Revenue from 2A s exceeding estimates - Commander Varela.

Special Presentation - 2026 Philip S Miller Nonprofit Funding Program applications

- Philip S. Miller Resource Grant Program The annual budget set for this program is \$45,000
- Pete Mangers gave a brief overview of the program. A cap of five individual grants is awarded annually. The budget for this program is reviewed and approved annually by Town Council.
 To be eligible, applicants must be a 501(c) (3) or 501(c) (19) organization. Funding requests must include provisions for the necessities of life: water, energy, food or shelter assistance
- Applicant presentations:
- American Legion Post 1187 requested amount: \$5,000
 Adjutant Larry Underwood presented an overview of Post 1187.
 The Post serves more than 180 local Post members and veterans at local retirement facilities.

The Post is run by all volunteers and is solely dependent on donations. Requested funding would be used to assist homeless and low-income veterans and current service members in meeting their food, shelter, and energy needs.

• Crisis Center - requested amount \$20,000

Executive Director Amy McCandless presented an overview of the center. The program provides emergency shelter, food, personal care items and community-based advocacy programs for victims of domestic violence. There is no duplication of services, as the Crisis Center is the only agency serving those impacted of domestic violence and has the only shelter of any kind in Douglas, Elbert and Lincoln Counties. The requested amount will be used for operational support for emergency shelter and community-based advocacy programs for victims of domestic violence.

 Deacons of New Hope Presbyterian Church - requested amount \$10.000

Moderator Joe Asbridge presented an overview of the program.
The Deacons of New Hope Presbyterian Church have a long-standing

history of helping community members who are experiencing financial difficulty.

Funds from this grant would be used to provide Castle Rock community members with financial assistance to pay rent, electric, gas, and water bills or to purchase food.

Faith Lutheran Church Food Pantry - requested amount \$20,000 Members of FGaith Lutheran Church Food Panty Church presented an overview of the program.

Faith Lutheran Church has been operating a food panty ministry since April 2020. This ministry is 100% dependent on financial and or food donations.

100% of the funds received through this grant would go towards the purchase of food. Any operating expenses are paid outside of the donations to this ministry.

Freedom Service Dogs - requested amount \$5,000

Deputy Director of Philanthropy Shanda Griebel presented an overview of the program.

Freedom Service Dogs provides service dogs to veterans and first responders in need, regardless of location.

This grant would help to support clients with travel expenses to the Denver area so that they can stay close to campus while they are in training with their service dog.

Help & Hope Center - requested amount \$20,000

Executive Director Dan Marlow presented an overview of the Center. The goal of the food bank is to provide at least seven days of food to residents in need, serving over 20 client households per day, five days per week.

Funding will not only support the on-site food bank but will also provide support for the agency's once a month off-site senior food banks located at Reyn Rock Plaza, Oakwood Apartments and Auburn Ridge - three low-income older adult housing facilities here in Castle Rock.

Lady Trailblazer Inc - requested amount \$2,500

Founder and CEO Dr. Carletta Stewart presented an overview of the organization.

The purpose of this grant will be to provide support for the Girls' Persist program, a STEM leadership program designed to assist girls in persevering in the areas of STEM disciplines.

Funding will be used to support student participants throughout the academic school year and summer camps.

Saint Vincent de Paul Society of Castle Rock - requested amount \$15,000

President Christina Steeg presented an overview of the organization. The purpose of this grant is to support Castle Rock low-income clients and/or those who are experiencing a sudden hardship such as a job loss or illness with rental, utility assistance, motel vouchers or food. Funding will be primarily used for temporary housing (motel), rent assistance, and utility assistance. With additional funds, Saint Vincent de Paul Society could potentially increase the number of clients helped and also increase assistance beyond the amounts currently offered.

• Commissioner comments:
