ORD 2016-018 Ordinance Approving the Fourth Amendment to the 2016 Budget and Authorizing Changes in Appropriations for Year 2016 (First Reading)

> Councilmember Heath noted the proposed budget amendment included repairs to property which was adjacent to property that he owned, and therefore recused himself from discussion and voting on this item.

Carner reviewed the proposed 4th amendment to the 2016 budget, noting the majority of the changes resulted from the accounting required to appropriately show the debt refundings recently approved by Council.

TABOR Ordinances

Based on Council discussion at the prior meeting, two options were presented for ballot questions requesting voter authorization to retain the 2015 TABOR funds in excess of the revenue cap: 1) for use on a long term water project; or 2) for use for Police, Fire, Emergency Medical Services, Transportation, Parks, Recreation, Trails and Open Space.

Heath recommended narrowing the scope of Option 2 to remove the Parks, Recreation, Trails and Open Space, limiting the authorized expenditures to Police, Fire Emergency Medical Services and Transportation.

Corliss also requested direction from Council as to the level of public outreach and communication desired.

The consensus of the Council was not to prepare a blue book on this issue.
