Accounting

The Accounting Team offers financial services, including accounts payable and receivable, investments, and capital asset reporting, ensuring transactions comply with the Town's Municipal Code, Governmental Accounting Standards, and relevant laws and regulations.



Payroll

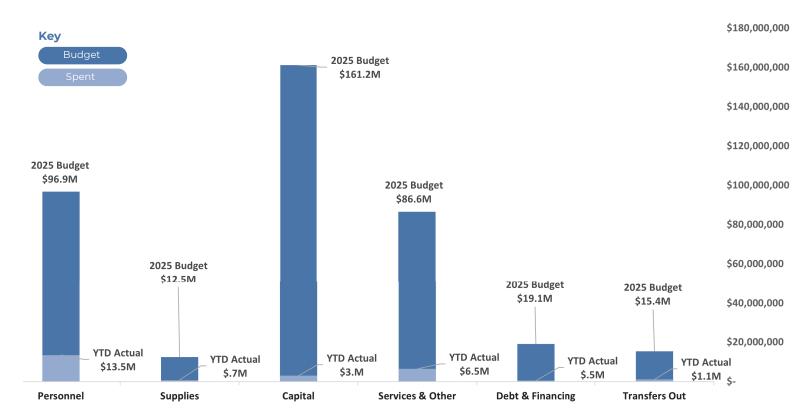

Through February 2025

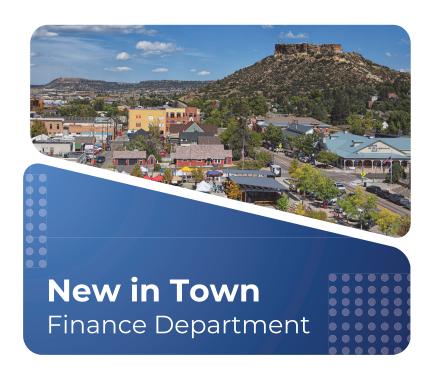

Did You Know?

In 2024, Castle Rock's budget totaled approximately \$337 million, with significant allocations to public safety, infrastructure and community amenities. Notably, the budget included:

- Public Safety Enhancements: Funding for three additional police officers and three firefighters, along with \$1.5 million for designing a new fire station and \$2.5 million for a new radio system for emergency services.
- Infrastructure Investments: \$117.9 million dedicated to capital improvements, including \$15.1 million for annual pavement maintenance and major projects like expanding the Plum Creek Water Purification Facility
- Community Development: \$10 million allocated for a potential down payment on a future sports and recreation center and \$4.75 million for open space acquisition.

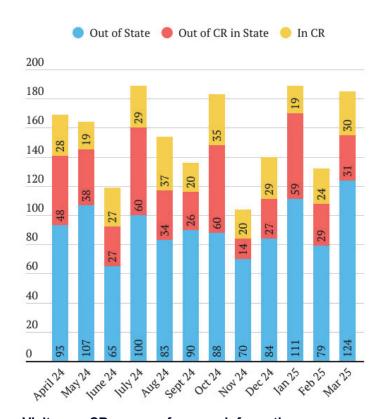

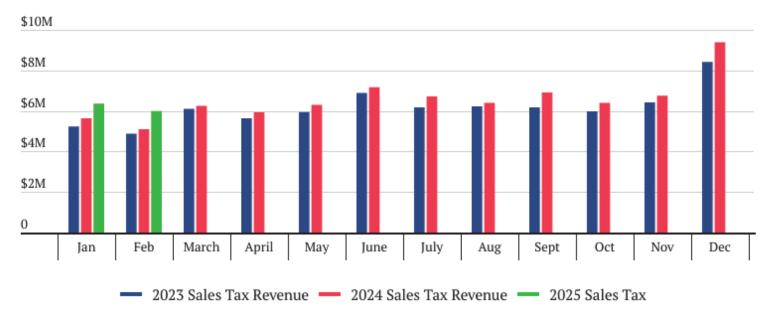

Sales tax collections for February were up **16.4 percent from the previous year's month, or up \$845,782** compared to February 2024. Year-to-date (YTD) collections are up **\$1,608,217 or 14.9 percent** compared to the same time frame in 2024. Staff will continue to monitor this very important revenue stream for the Town and inform as needed.
