Statement of Intent to Circulate a Petition
For the Purpose of Amending the Castle Rock Town Charter

Town Clerk Misare,

In accordance with Colorado Revised Statutes §32-2-210, the undersigned Committee for Citizens for Elected Mayor, residents of Castle Rock, Colorado, intend to circulate a petition for the purpose of amending the Castle Rock Town Charter to allow for the at-large, town-wide election of the office of Mayor. The petition will call for a special election for the Town of Castle Rock on November 7, 2017 that will be coordinated with the Douglas County Clerk pursuant to §1-7-116, C.R.S..

Summary of Change Desired


So that the residents of Castle Rock can elect their Mayor, shall there be a question on the November 7, 2017 ballot asking if the town charter should be amended to allow an at-large, elected Mayor position to serve for a four-year term; and that the Mayor shall represent the town with the same voting authority as the other members of Town Council; and that Town Council shall consist of six by-district councilmembers and the at-large Mayor?


Full Text (suggested submission clause)

And in order to allow for the election of a Mayor, shall section 2-2 of the town charter be amended to state: "The Town Council shall consist of an at-large Mayor and six Councilmembers, each of whom shall be elected from the district in which he or she resides."; amending 2-5(a) to read: "The At-Large Mayor shall serve no more than two four-year terms. At the organizational meeting provided for in Section 2-3(c), the Council shall elect by majority vote of the entire Council one of its members as Mayor pro-tem who will serve until the next organizational meeting unless removed by a majority vote of the entire Council."; in section 2-6 adding "or Mayor" after "Councilmember"; in section 2-7, "and Mayor" shall be added after "every councilmember"; in section 2-3(b) adding "and Mayor" after "The Councilmembers."


Upon receipt of this statement of intent, Committee for Citizens for Elected Mayor request a written determination within five (5) business days, from the Castle Rock Town Clerk that the attached petition is in compliance with §31-2-220 and §31-2-223(1) so that circulation of the petition may begin.


