As a citizen of Castle Rock for ten years, I am writing to express concern over recent efforts to change the definition of adult entertainment to include drag shows. We already have ordinances in place to restrict adult entertainment, and it is reasonable to maintain those. However, we must make sure that the wording of any ordinances cannot be used to define all drag performances as adult entertainment.

Drag is not new, and it is not immoral. Half of Shakespeare's comedies include cross-dressing and suggestive jokes. So did Monty Python, M.A.S.H., and Bugs Bunny. So, it seems to me that the recent attacks on drag shows are jumping on a culturewars bandwagon driven by discrimination against a small and already-vulnerable population. Yes, some drag shows include risqué content, but drag is not inherently sexually explicit, and they aren't grooming anyone but themselves! Children are likely to be exposed to similar or more explicit content on television or other media, and it's up to parents and other caregivers to monitor what their children see. Existing regulations are sufficient to 'protect the children.'
