

FIRST AMENDMENT TO AGREEMENT 504649

THIS AMENDMENT to Agreement No. 504649 ("Amendment") is made and entered into between CITY AND COUNTY OF DENVER, acting by and through its BOARD OF WATER COMMISSIONERS ("Denver Water"), PARKER WATER AND SANITATION DISTRICT, a quasi-municipal corporation under C.R.S. §§ 32-1-101(1) and 32-1-1006(1) ("PW&SD"), EAST CHERRY CREEK VALLEY WATER AND SANITATION DISTRICT, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE ("ECCV"), and the TOWN OF CASTLE ROCK, a municipal corporation of the State of Colorado, acting by and through its Castle Rock Water Enterprise ("Castle Rock Water"). Denver Water, PW&SD, ECCV, and Castle Rock Water are referred to herein each as a "Party" and collectively as the "Parties."

WHEREAS, the parties entered into Agreement No. 504649 dated January 21, 2021 ("Agreement"), and wish to amend it; and

WHEREAS, the Agreement needs to be extended to allow more time to complete the Work.

NOW, THEREFORE, the Parties agree as follows:

1. The date for completion of Work under the Agreement is extended to December 31, 2028. The Parties agree to continue all insurance coverage required under the Agreement through the extended completion date of the Agreement.

2. The Parties consent to the use of electronic signatures. The Parties agree not to deny the legal effect or enforceability of the Agreement solely because it is in electronic form or because an electronic record was used in its formation. The Parties agree not to object to the admissibility of the Agreement in the form of an electronic record, or a paper copy of an electronic document, or a paper copy of a document bearing an electronic signature, on the ground that it is an electronic record or electronic signature or that it is not in its original form or is not an original.

Except as specifically amended in this Amendment and any previous amendments, the Agreement shall remain in full force and effect. The effective date of this Amendment is the date it is executed by the last Party to sign.
