


BACKGROUND


- Distribution and collection system was installed in the mid 1970's
- History of leaking joints, cracked pipes, root intrusion and increased maintenance
- Condition assessment of manholes and gravity sewer main conducted
- Existing pipe is 6" (1,336 LF) and 8" (11,987 LF) vitrified clay pipe
- Some portions have been lined recently this is final portion



PROJECT APPROACH

- Cured-In-Place Pipe (CIPP) Rehabilitation
- Trenchless pipe lining method
- Fully structural pipe within existing pipe
- Town has lined 8+ miles of clay pipe with CIPP





- Pre-lining CCTV inspection
- Cured-in-place-pipe 6" 402 LF
- Cured-in-place-pipe 8" 4,058 LF
- Lateral reinstatements
- Limited excavation in Right-of-Way (ROW)
 - No asphalt/concrete disturbance
 - Service connections in ROW included in future waterline replacement project ~ 2025
 - Lining operations on South Street only during school breaks

- Total cost \$322,837+\$32,284 Contingency = \$355,121 Authorization
