Philip S. Miller Park Art Project Call for Entries

Staff Updates

Staff updated the Commission regarding the cabinet wrap installation at Philip S. Miller Park. Since the Parks and Recreation Department agreed to pay \$1,600 of the project's final invoice due to the addition of cabinet panels, the total amount that was expensed to the Public Art Fund was \$7,952.42.

William Slater of the Public Art Collective applied warning labels to each of the appropriate electrical cabinets. Slater also recreated and installed tipping hazard and field connection signs. Slater will soon be installing artist and Public Art Commission plaques to complete the project.

Lastly, staff passed along the cleaning and care instructions to the Parks Maintenance Division.
