ADVERTISED PUBLIC HEARINGS & DISCUSSION ACTION ITEMS

The motion passed by a vote of:

<u>ID 2015-264</u> Presentation: Proposed 2016 Budget

Corliss presented overview of 2016 budget and requested confirmation from Council that the proposed expenditures were in keeping with Council's stated strategic goals and priorities. Reviewed projected revenues and expenditures and highlighted the planned use of reserves for several capital projects. Noted the entire draft budget and line item detail, as well as the Budget in Brief document and copies of the power point presented at this meeting were available on the Town's website, and citizens were encouraged to review the documents. Additional public hearings on the 2016 Budget would be held November 3 and December 1, 2015.

The following members of the public made statements or asked questions on this item:

Steve Williams Ann Dorzweiler John Buckley Bev Williams Caroline Cline Wilson moved to put a place holder of \$800,000 in the 2016 Budget for the quiet zone.

The motion FAILED for lack of a second.

It was the consensus of the majority of Council to direct staff to prepare the 2016 Budget for adoption based on the draft as presented at this time.

ORD 2015-46

Ordinance: Amending Title 3, 4 and 13 of the Castle Rock Municipal Code by changing the Water, Wastewater and Stormwater Monthly Services Charges and Fees, the Renewable Water Resource Fee, The Water and Wastewater System Development Fees and the Stormwater Development Impact Fee, and Authorizing the Administrative Adoption of the Utility Administrative Fee Schedule (First Reading)

Marlowe stated there were no changes to the proposed rate and fee structure presented to Council on October 6, 2015. The Utilities Commission recommended approval as presented.

<u>ID 2015-265</u> Discussion/Direction: Festival Park Redesign

Jeff Zimmerman and Jake Sippy of Design Workshop reviewed the latest conceptual plan for the redesign of Festival Park, based on input obtained at a series of public meetings. Design focused on park amenities, arrangement of features, function of the design, material selection and interface with surrounding properties.

Brauer provided a brief overview of implementation strategies and possible funding options.

Councilmember Wilson expressed concern about the safety for pedestrians in this area of downtown once all the enhancements were added, and stated the

implementation of a quiet zone should be considered as an important part of this plan.

Valentine moved, seconded by Teal, to support the conceptual redesign of Festival Park as presented by Design Workshop and directed staff to bring back a detailed plan for implementing the project, including the necessary construction drawings, phasing schedule of the project, and funding the construction.

Slentz presented overview of proposed amendments to the Town's Election Code, which would be used to govern any election which the Town was required to conduct independently of the County.

Specifically highlighted change to the existing definition and threshold contribution in order to be considered an issue committee which were consistent with current court rulings.

It was the consensus of Council to direct staff to finalize this Ordinance and bring it back for Council review and consideration.
