Councilmember Cavey asked if they could have the Brickyard neighborhood meeting here. Vargish stated it is held across the street at the Riverwalk.

TOWN ATTORNEY'S REPORT

Mike Hyman, Town Attorney, reported on the US Supreme Court ruling on the overnight camping issue. They ruled that the cruel and unusual punishment argument prohibiting overnight camping was reversed. They determined the punishments were not cruel or unusual i.e., fines. Camping bans forbid conduct and are not limited to homelessness. If enforced regardless of housing status it is not violating the Constitution. Hyman felt the ordinances the Town enacted last year makes it unlawful to use a tent or unauthorized structure for the purpose of shelter in parks, rec areas or public property, and bans camping or waste within 100 feet of storm drainage or waterways.

Mayor Pro Tem LaFleur asked for examples.

Councilmember Cavey confirmed we can cite them. Hyman stated it is in regard to structures for the purpose of shelter or storage. Repeated offenses can carry tougher punishment up to jail time. Can also use obstructing public views.

Mike Hyman, Town Attorney, and Tara Vargish, Development Services Director, provided an overview. Details are provided in the packet.

Vargish confirmed we are not allowed to prohibit this type of business. Councilmember Dietz wants to know what thoughts are about increased crime. Hyman feels the restrictions they propose will provide the highest security. Councilmember Dietz asked what other violations could they be cited for. Hyman stated they have included a nuisance clause in the ordinance that it is unlawful or a nuisance if they are in violation of state law or this chapter.

Councilmember Cavey inquired about the parcel closer to Dawson Trails and where the schools are proposed. Vargish stated that is on the southern area away from that parcel. She further stated if the area to the north of that small parcel is developed prior to a business going in there, it would prohibit that use.

Councilmember Dietz feels the restrictions are good; but is concerned that it can creep in. As long as we can maintain these restrictions and maintain home rule.
