### Fire Department Report

#### Fire Department Report

Chief Bersagel-Briese invited Commission members to attend the Castle Rock Fire Department (CRFD) Awards Dinner. Commission members are asked to RSVP to Lori Kania at the Fire Department.

#### NERIS Update

The Chief provided an update on the National Emergency Response Information System (NERIS), a software system developed by UL Laboratories and the Fire Safety Research Institute. NERIS is a national reporting database required by FEMA, and participation is necessary for agencies to remain eligible for grant funding. The system generates real-time data for the fire service and is anticipated to add only a few minutes to call reporting.

Commission Member Morton asked whether CRFD receives grant funding. The Chief confirmed that CRFD does receive some grants, including funding for LUCAS devices used with breathing apparatus. Grant applications are reviewed by a scoring and evaluation team.

#### Fire Conditions and Operations

Dry weather conditions continue to increase fire danger, and the long-term

forecast does not indicate significant moisture increases in the near future. Blasting operations are occurring in the Ridge and Plum Creek areas as part of residential development. These activities are monitored by the Fire Department.

**Station 156 and Apparatus Updates**

- Station 156 continues to progress as planned.
- Financing is expected to be finalized within the next month.
- The project is anticipated to be presented to Town Council between mid-February and March.
- Final acceptance of Pierce apparatus is expected in February.
- Estimated completion of Station 156 is summer 2027.
- Personnel are in place to staff the new station.

**Training, Staffing, and Leadership Development**

- Command staff will attend leadership training during the week of January 12.
- A leadership consultant is scheduled to begin work with the department in February.
- The department is launching a professional development initiative focused on soft skills over the next several months.
- A transition academy for newly graduated fire academy recruits began in January. They will move online later in the month.
- Due to improved/early staffing levels, four firefighters will be sent to paramedic school.
- The new Division Chief of Logistics began on January 5.
- Firefighter/Paramedic Mike Zukowski retired in December after 26 years of service with CRFD.

**2025 Year-to-Date Statistics**

- Overall call volume increased by 4.6%, consistent with the past three years.
- 96 fire incidents
- Approximately 4,700 EMS incidents
- Station 154 had the busiest engine, responding to approximately 2,400 calls.
- Firefighters train an average of three hours per day, totaling more than 10,000 in-person training hours department-wide.
- The Life Safety Division completed approximately 2,350 inspections.

**EMS and Community Response**

The department is addressing a significant number of EMS calls originating from the Banyan Treatment Center. The EMS Chief is working collaboratively with Banyan, Douglas County, and local officials to ensure appropriate patient intake processes.

The Co-Responder Team (CRT) continues to be a valuable resource, particularly for community members with frequent and repeat contact with emergency services.

**Communications and Staffing During High-Risk Periods**

The Chief addressed questions regarding firefighter communications, noting that while personnel can communicate effectively, there are opportunities for improvement through the use of mobile data terminals (MDTs) and Bluetooth technology.

Commission Member Knotts asked about staffing during high-risk periods such as fireworks usage around the New Year. Chief Bersagel-Briese reported there were no major fireworks-related incidents on New Year's Eve. During periods of elevated wildland fire danger, CRFD increases staffing by deploying a brush truck.

## Police Department Report

### **Police Department Report**

#### **Recruitment and Staffing Updates**

The Police Department is currently conducting a lateral police officer recruitment to fill four to five positions.

Commission Member Morton asked about cost savings associated with lateral hires. Chief Cauley explained that the primary benefit is the ability to deploy experienced officers to the field more quickly. Lateral officers typically complete field training faster than academy graduates, allowing them to serve the community sooner.

In December, CRPD welcomed 12 new employees, including six academy graduates and six lateral hires. Due to the high number of members currently in training, residents may notice patrol vehicles staffed by two officers.

Eight staff members who were promoted in December officially assumed their new roles on January 3.

#### **Community Programs and Engagement**

The annual **Heroes and Helpers** event was held at Walmart on December 13.

Through donations, the program supported more than 200 children and their families this year.

The department has also found that pickup trucks used by officers have been beneficial for community policing efforts and offer quicker delivery times compared to traditional patrol vehicles.

#### **Crime and Enforcement Updates**

A bank robbery suspect, Octavio Rivas Morales, was sentenced to 22 years in prison for the September 2024 armed robbery of a Castle Rock bank.

The Special Response Team (SRT) made several successful organized retail crime arrests during the holiday season.

Commission Chair Hammelman asked about the number of traffic stops versus tickets issued. Chief Cauley explained that not every traffic stop results in a citation, as officers often use stops as educational opportunities rather than enforcement actions.

Commission Member Knotts inquired about the single "robbery" statistic reported in the October monthly report. Chief Cauley clarified that the incident met the statutory definition of robbery under Colorado law but was not an armed robbery.

#### **Animal Control and Reporting**

Commission Chair Hammelman asked whether veterinarians are required to report dog-on-dog bites. Chief Cauley explained that veterinarians are only required to report dog bites involving humans.

#### **Officer Wellness and Mental Health Services**

Commission Member Van Court asked about mental health services available to police staff. Chief Cauley explained that the department contracts with multiple providers to support employee wellness. Services include mandatory annual mental health check-ins (conducted in person or virtually), critical incident debriefings, and individualized counseling for members requiring additional support following major incidents.

#### **Traffic and Technology Updates**

The department continues to enforce regulations related to electric scooter use and emphasized the importance of parents understanding and educating youth on

traffic laws.

Two police drones are currently operational, with plans to add an additional drone in the future.

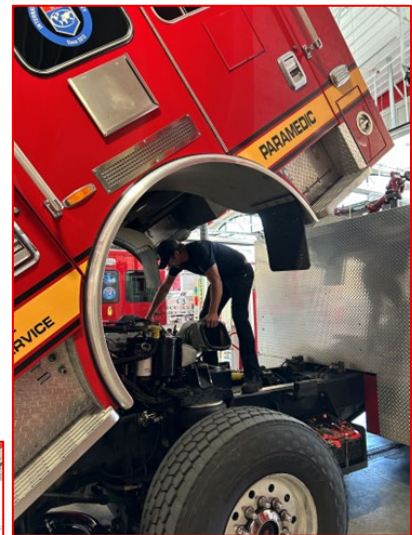

## **Operations Division:**

**Deputy Chief Oren Bersagel-Briese**

### **Deputy Chief Commentary:**

Congratulations to Mike Zukowski for his well-deserved retirement after serving the citizens of Castle Rock for more than 25 years. When Mike started, he and I were assigned to putting a second medic unit in service – but only during high-use parts of the week. Our schedule was Wednesday through Sunday from noon to midnight, and while it wasn't the easiest schedule, Mike focused on the fact that it was what the department needed.

Mike's professional legacy will be centered on his deep passion for helping others, his commitment to the brothers and sisters at the CRFD (including everything he did for Jeff Dunn), a bit of pragmatic quirkiness, his joy of being a dog handler for COTF-1, and some great chili. Congrats, Mike!

---

NERIS: We were able to begin testing on the new NERIS incident reporting platform in the second half of the month, and are appreciative of the lieutenants who volunteered to pilot the new system. The department is mandated to move to that platform on January 1, and we anticipate that we'll see continuing system changes and reporting requirements over the next few months. Thank you for everyone's patience through this change!

EMS: BLS Attending training was completed for the department and the updated program will go live in January. Training was also provided for the Transition Academy, and we've been working with Training on the plan for 2026's EMS training. We continue to work through response considerations at Banyan and have seen more than a 30% reduction in our average monthly responses to their facility, while we continue to see increases in other areas of EMS response. Dr. McDaniel is now officially functioning as our medical director and we'll continue to make the transition to his leadership over the next few months. The EMS shift leads have already made an impact and have become a resource for communication for each shift. Lastly, we are addressing equipment issues as they arise, and appreciate everyone's willingness to bring these to our attention.

Special Operations: Leads continue to prepare for the upcoming regional Tech Rescue Academy and planning for next year's department-level trainings. We attended several regional meetings, including the South Area Spec Ops meeting and one focused on hazmat and active threat. Finally, Andrew Kopp is our new Trench Rescue Lead and is working with Seth Roan and Troy Robberson as he transitions into that role.

Pipes and Drums: The band concluded 2025 with a busy month, playing at the Highlands Ranch Law Enforcement Academy graduation ceremony, the LODD funeral service for Adams County Sheriff's Office Commander Karl Smalley, the 25-02 West Metro Fire Academy graduation ceremony, and Mike Zukowski's retirement ceremony.

Apparatus: Engine 156's completion has been scheduled for mid-January at Pierce and members of the Apparatus Team will travel to Wisconsin for the final inspection. Brush 156's repairs are also completed, and Ben Jennings will travel to South Dakota to conduct an inspection prior to bringing it to Castle Rock.

We are currently working on the following projects:

- SOG/Admin Directive updates
- Station 155 updates for M155
- New reserve engine in-service process
- Updating our bunker gear spec
- 2026 training plans for EMS/SpecOps

- Participated in Aurora's Division Chief interview process

### **Call Statistics:**

For December, we responded to 669 calls for service. For the year, we have now responded to 7,403 calls, which is 335 more than at the same point in 2024. We averaged 21.5 calls per day for the month.

Of the 669 calls this month, 12 were fire-related, 34 were motor vehicle crashes, 88 were service in nature, 382 were EMS calls, 73 were good intent calls, 63 were alarms, and the remaining

were miscellaneous. In December, we transported 328 patients to area hospitals, with 261 transported to Castle Rock, 51 to Sky Ridge, and 16 to other facilities.

## **Administration Division:**

### **Fire Chief Norris Croom**

#### **Key Admin Issues:**

After 25 years of service, FF/PM Mike Zukowski retired on December 29<sup>th</sup>. Earlier in the month, Mike received the 2025 First Responder of the Year from the Masonic Douglas Lodge 153.

During Mike's tenure, he served in a variety of positions, played bagpipes in the Pipes and Drums, was Chief Cook for the annual chili supper for a number of years, and most notably, as a search dog handler for Colorado Task Force 1. Congratulations Mike!



On December 19<sup>th</sup>, our seven recruits graduated from the joint West Metro Fire Academy with our own FF/EMT Chris Sison receiving the Top Recruit Award. They are now in the transition academy here, and should move to their line assignments in January. Congratulations to all and welcome!

We have developed a scope of work (SOW) with the Colorado State Forest Service for mitigation of about 20 acres of the forested portion of the Metzler Family Open Space along Crowfoot Valley Road. We are still working with the Douglas Land Conservancy (DLC) to obtain approval before we can put this out to bid.

We are working to schedule Council approval for the entire Station 156 project in February or March once financing has been secured, and then construction to begin soon thereafter. We have multiple submittals already in to Development Services, to include construction drawings, replat application, etc., and are working on the review comments. We have not encountered any significant challenges so far, and continue to work on coordination between all involved.

#### **Fire Chief Commentary:**

Due to continued dry and windy weather conditions, Stage 1 Fire Restrictions were implemented in Town as well as by Douglas County. We participated in a number of meetings with Douglas OEM and Xcel as they implemented Public Safety Power Shutoffs (PSPS) throughout the front range due to high fire danger. While the Town was not included in these as we are served by CORE, we were prepared to assist elsewhere if needed.



While we have been fortunate in not having many grass/brush fires during this time, we did respond to a 1-acre grass fire in Crystal Valley on December 23rd. The fire was quickly contained due to aggressive work by our crews, and the cause was determined to be fireworks. We had several crime stopper tips, and our investigators are continuing to work on follow-up.

I participated in the HR Manager interviews at the request of the Town Manager's office. At the conclusion, we had a solid recommendation to move forward in the process, and that individual was given a conditional offer pending the background check process. If all goes well, they will hopefully start in January.

Bob Norton, with Norton Development Group, submitted his recommendations and plan for the next steps based on the interviews he conducted in November. I have reviewed his recommendations, and we will be moving forward with a number of them to start.

We have dates blocked in January and February for in person training with him, and we will evaluate how to proceed at the conclusion of these trainings.

## **Fire and Life Safety Division:**

**Division Chief Kevin Sullivan**



### **Fire and Life Safety Division Summary:**

- Blasting operations continued in the Ridge Road–Plum Creek corridor with daily safety checks, vibration monitoring, and community communication support.
- The division completed 104 inspections, reviewed 79 plan submittals, and inspected 1,961,075 square feet.
- Division fee revenue totaled \$14,651.59.
- Fire and investigation staff handled 16 responses and follow-ups and completed 12 unmanned aerial vehicle (UAV) flights.
- Life Safety Educators delivered 3 public education events (4 hours) with 84 in-person contacts and 15,104 digital contacts.

### **Blasting Operations Update**

Blasting commenced in the corridor between Ridge Road and Plum Creek. Work in December required daily pre-blast and post-blast safety checks, vibration monitoring and compliance confirmation, community communication support, and UAV flights for documentation.

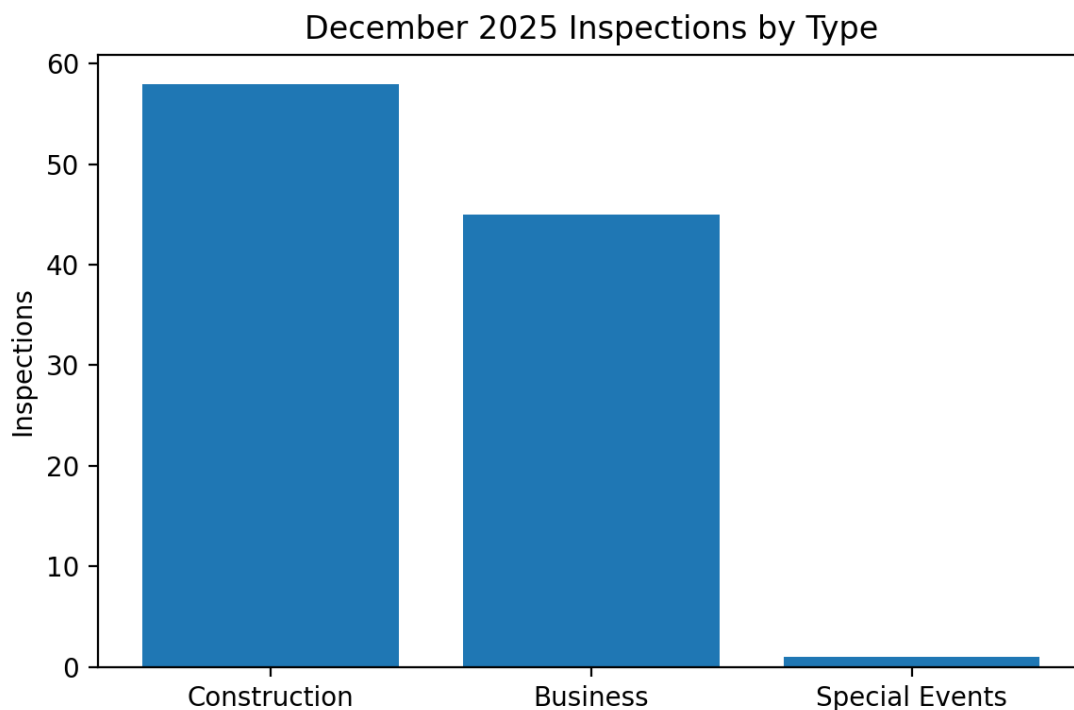

### **Plan Review and Development Services**

Development Services plan reviews remained steady, with 66 plan reviews completed in December. The division also completed 12 system-specific fire plan reviews and reviewed one special event plan, for a total of 79 plan reviews.

Staff participated in 23 Development Services meetings to coordinate plan review timelines, resolve technical issues, and support project delivery.

### **Compliance and Deficiency Tracking**

System status tracking shows a mix of current and past-due systems, along with overall compliance and deficiency rates. The charts below reflect the current snapshot and deficiency activity trends.

### **Community Risk Reduction and Public Education**

Life Safety Educators completed three public education and community events totaling four hours. Staff made 84 in-person contacts, including 60 children and 24 adults, and recorded 15,104 digital contacts during the month.

December messaging emphasized holiday safety for residents and blocked exits and egress lighting for businesses.

### **Public Education Highlights**

Educators attended an all-day training with Castle Rock Police Department focused on autism, the C.A.R.E. program, and community input on special needs populations.

Educators partnered with the police department to distribute Spanish fire safety materials to multiple schools.

Staff coordinated with the police department's victim advocate group regarding car seat resources for community members.

Safer Senior programming was delivered to Reyn Rock residents, focusing on emergency preparedness, medical emergencies, and home fire safety and prevention.

Educator professional development included a car seat continuing education training and Town communications training focused on web content quality.

### **Car Seat Education**

Crews and educators completed 15 car seat checks in December, all of which were rear-facing seats. Staff identified and corrected four installation errors.

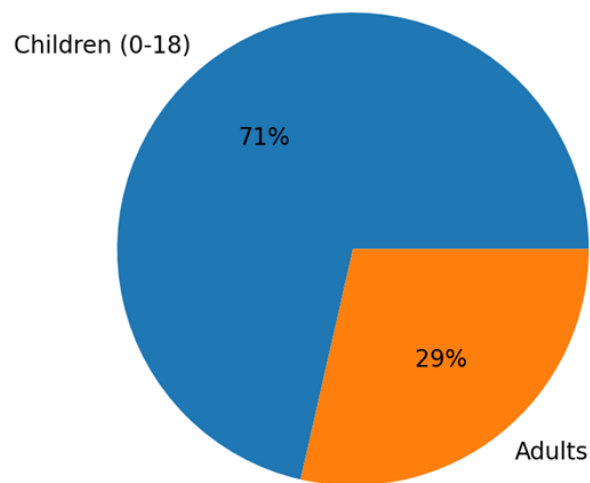
### **Digital Outreach Snapshot**

PulsePoint reporting (one month in arrears) shows 1,923 users following CRFD enabled CPR alerts, with 6,603 monthly active users.

Social media reporting (one month in arrears) shows the CRFD Facebook page reached 189,762 people in November, with 1,938 post engagements and 136 shares.

December Facebook page metrics included 7,716 followers, 1,641 likes and reactions, and 324,855 page views.

## **Training Division:**

**Division Chief Jeff Hood**



**Division Commentary and Happenings:** December closed out a productive year for the Training Division. The department logged 2,460 training hours in December, bringing the 2025 total to 35,332 training hours. While this number is slightly elevated due to the significant workload associated with onboarding and training 16 new-hires, it reflects our Department's overall commitment to training, development, and operational readiness.

**Department-Wide HazMat / CO<sub>2</sub> Training:** The Training Division delivered department-wide hazmat training in collaboration with 105 West Brewing Company, providing hands-on CO<sub>2</sub> response training at their facility. This partnership allowed crews to train in a real-world environment involving a hazard we may encounter but rarely get the opportunity to train on in person. Crews rotated through the brewery, learned about CO<sub>2</sub> systems, associated hazards, and operational considerations, and gained valuable experience responding to a unique but realistic risk.

**West Metro Academy Graduates and Transition Academy:** Seven entry-level recruits successfully graduated from the West Metro Fire Academy and began CRFD's Transition Academy in December. Training includes skills evaluations, engine and quint days, wildland operations, technical rescue, hazmat, EMS, SCBA familiarization, radio operations, and more. The Transition Academy will conclude on January 16, highlighted by a presentation from retired FDNY Captain Mike Dugan. Following graduation, recruits will attend a one-week car seat class and are anticipated to begin line assignments the week of January 26.

**Acting Lieutenant Academy:** The Training Division conducted the Acting Lieutenant Academy, delivering a well-rounded curriculum intentionally designed to satisfy both CRFD expectations and CMCB Fire Officer requirements. Instruction covered leadership styles, resilience, peer support, decision-making, difficult conversations, organizational conduct, administrative responsibilities, behavioral health, and report writing, as well as operational topics including strategy and tactics, fire systems, and use of departmental reporting platforms. As part of this effort, all of our future acting lieutenants earned their Fire Officer certifications.

**Safety Training Officers (STOs):** STOs continue to provide and support hundreds of hours of training throughout the month. In addition to delivering operational training, STOs played a role in year-end administrative support, assisting members with expiring certifications and outstanding training requirements. One notable training initiative included the development of a low-visibility forcible entry prop at the training tower. Practicing tool use in low-visibility conditions is not something the department has traditionally emphasized at a large scale. This training provides valuable exposure to the increased injury risks associated with tool use in

reduced visibility and helps reinforce safer techniques.

### Other Division Happenings:

- Planning continues for the April 2026 Acting Engineer Academy and the June Engineer promotional process.
- The division is exploring longer-term training initiatives, including potential mid-rise operations and acquired residential structures.
- Evaluation of major training tower upgrades for 2026 is ongoing.
- Coordination continues with the Water Treatment Plant to develop department-wide training.
- Preparation continues for a department-wide elevator rescue training.

The ImageTrend Connect26 conference will be taking place May 11-15, 2026 in Saint Paul, Minnesota at the Saint Paul River Centre.

### Looking Ahead:

Data from 2025 will begin being collected in the first quarter of 2026 and will be reconciled and prepared for the Annual Standards of Cover and Annual Compliance Report. While these reports are required for accreditation renewal, they also offer valuable insight to help guide our department's future planning.

In 2025, CRFD experienced an estimated 4.75% increase in calls for service compared to 2024. Below are the projected month-to-month figures and total annual call volumes for apparatus throughout the department:

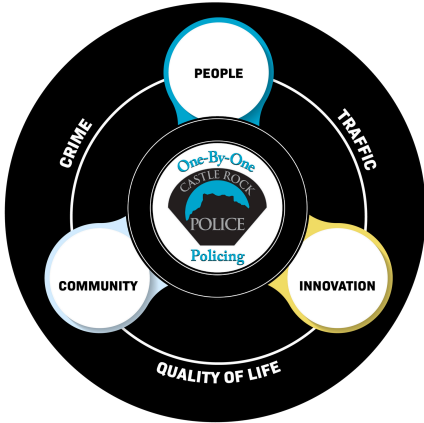

### A message from Chief of Police Jack Cauley

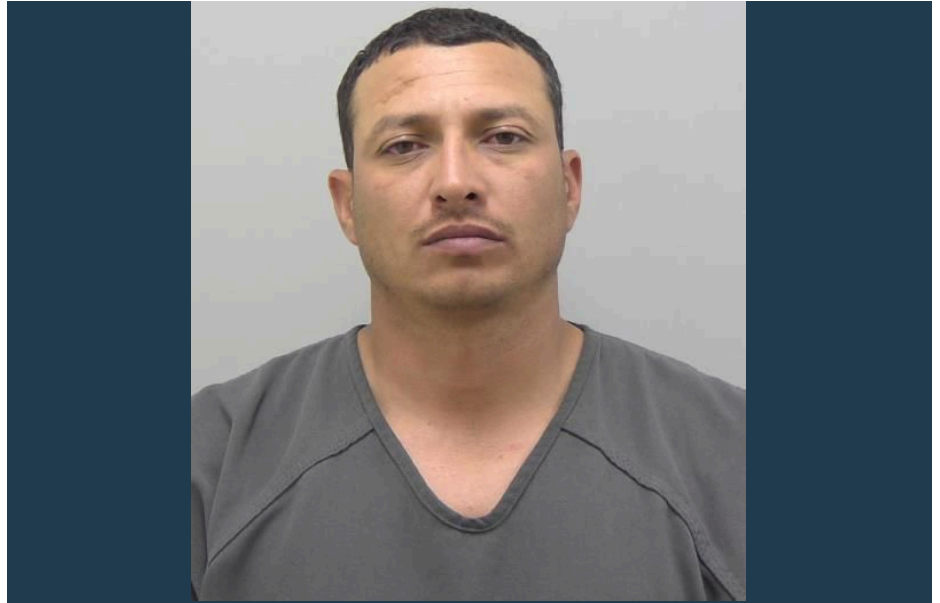

## Armed bank robber sentenced to 22 years

In Dec. 2025, Octavio Alan Rivas Morales was convicted and sentenced to 22 years in prison for an armed robbery at a Castle Rock bank. In Sept. 2024, Rivas Morales entered the bank armed with a handgun, fired a round into the floor to intimidate employees and customers and fled with approximately \$2,000 in cash.

Castle Rock officers and detectives quickly responded to the scene, and it was determined no one had been injured. Good citizen statements, along with evidence collected, allowed officers to identify the suspect and his getaway vehicle within minutes of the crime occurring. CRPD then tracked the suspect to a location in Johnstown. Working in conjunction with the FBI's Rocky Mountain Safe Streets Task Force and the Johnstown Police Department, the subject was taken into custody without incident.

"The diligent work done by our department, combined with a community that has zero tolerance for crime, makes Castle Rock an environment where bad actors can't get a foothold," Chief of Police Jack Cauley said following Rivas Morales' arrest.

As part of a plea agreement, prosecutors sought a punishment of up to 22 years in prison. During sentencing, the judge stated Rivas Morales posed an extreme danger to the victims and community and imposed the maximum sentence.

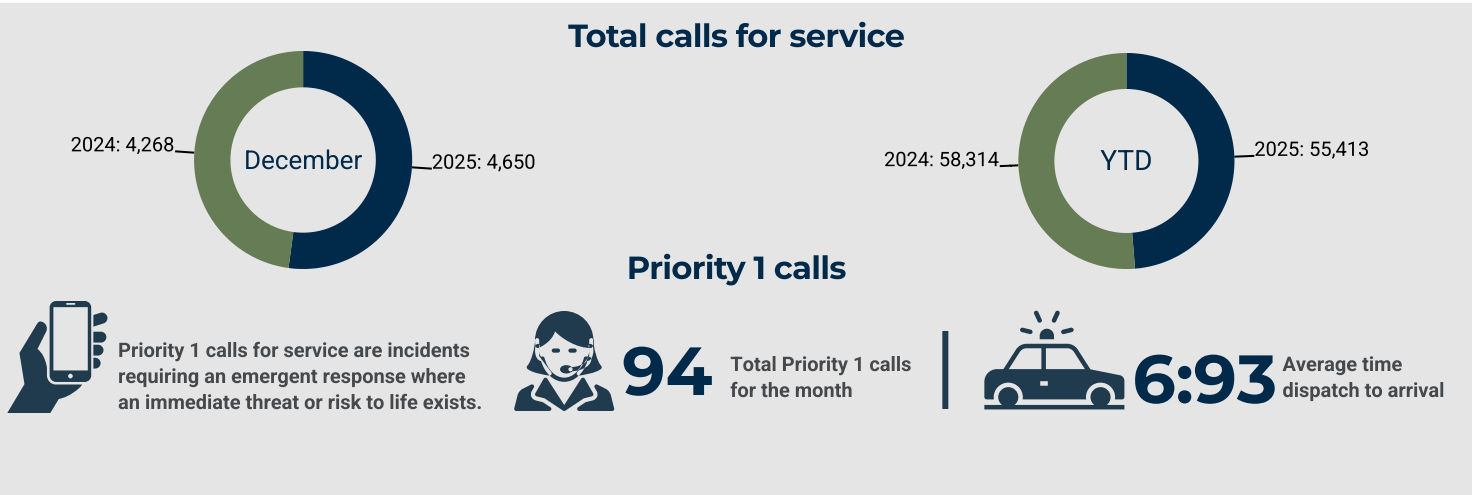

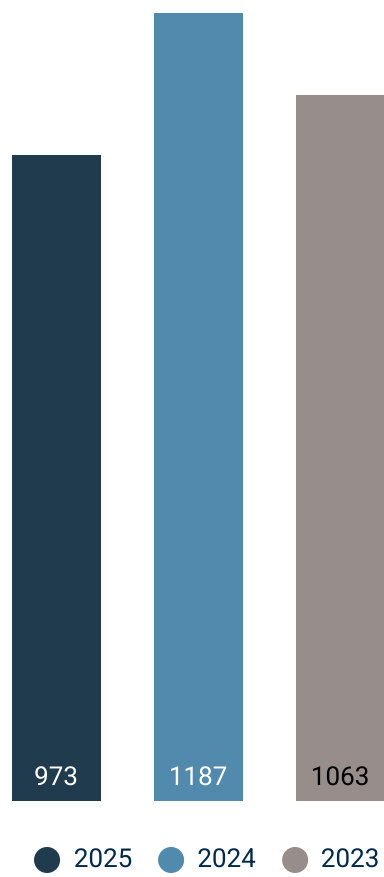

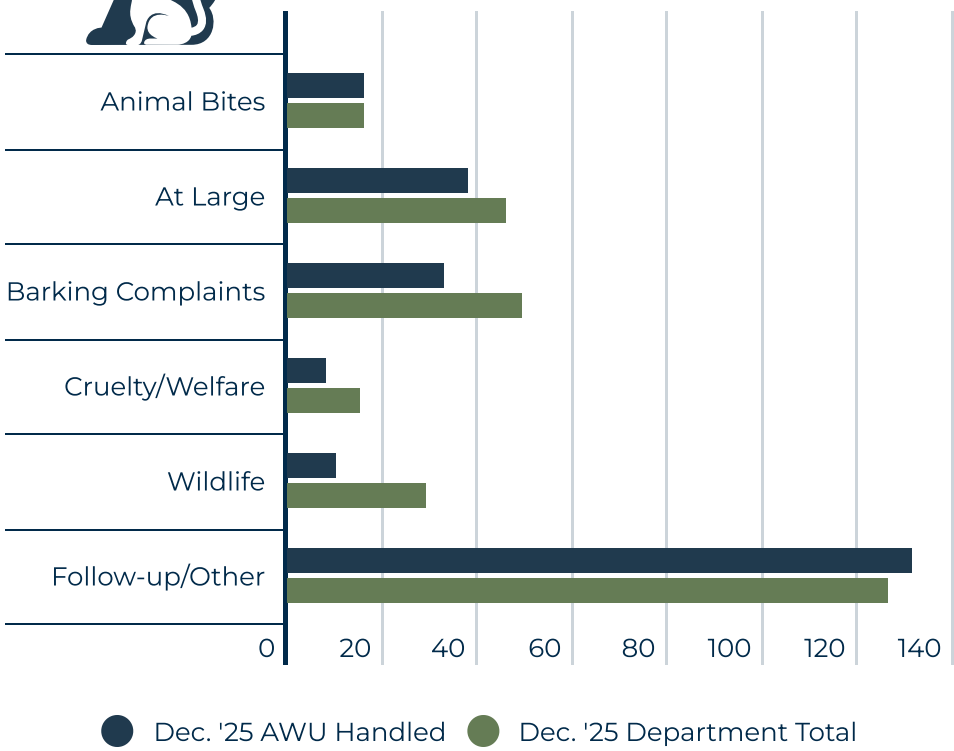

## Community Response Team: Calls for service

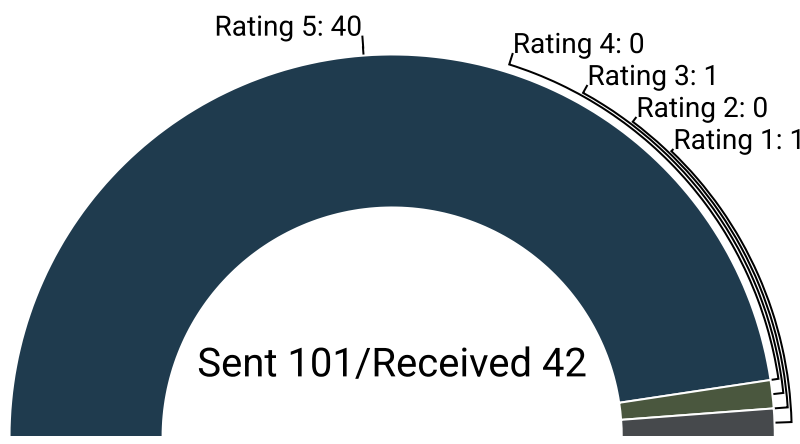


## Animal Welfare Unit: Calls for service
