

**RENEWAL OF
TOWN OF CASTLE ROCK SERVICES AGREEMENT
TO PROVIDE ON-CALL WATER QUALITY CONSULTING**

DATE: February 26, 2021

PARTIES: **TOWN OF CASTLE ROCK**, a Colorado municipal corporation, 100 N. Wilcox Street, Castle Rock, Colorado 80104 (Town).

CDM Smith, INC., A Massachusetts Corporation, 555 17th Street, Suite 500, Denver Colorado 80202 (“Consultant”).

RECITALS:

A. The Town and Consultant are parties to the Town of Castle Rock Services Agreement to Provide On-Call Planning On-Call Water Quality Consulting Services, dated May 21, 2019 (the “Agreement”).

B. Pursuant to Section 3 of the Agreement, the parties may renew the Agreement under the same terms and conditions for an additional one-year term.

C. The parties desire to amend the Agreement to update the hourly rate and fee schedule for the Services, and extend the term of the Agreement for an additional one-year term, expiring on December 31, 2021.

TERMS:

Section 1. Renewal of Agreement. Upon execution of this Renewal Agreement, the term of the Agreement be extended to December 31, 2021.

Section 2. Amendment. The rate and fee schedule attached as Exhibit 1 to the Agreement is amended and replaced with the attached Exhibit 2 - 2021.

Section 3. Remaining Terms. All other terms and conditions set forth in the Agreement shall remain in full force and effect, including the rights for early termination.
