Proclamation: My Water Pledge, Mayor's Challenge [For Council Action - Presentation

on April 6, 2021]

Executive Summary

My Water Pledge is a friendly competition between cities across the United States to see who can be the most "water-wise" and get the most pledges. Mayors, nationwide, will challenge their residents to conserve water, energy and other natural resources on behalf of their city through a series of informative, easy-to-use pledges online at MyWaterPledge.com. Pledges can be completed by citizens starting April 1, 2021 and going until April 30, 2021. The online pledge asks a series of questions regarding individual conservation behavior and requires less than two minutes.

The non-profit campaign is presented nationally by Toyota and the Wyland Foundation, in association with National League of Cities, Environmental Protection Agency (EPA) Office of Water, U.S. Forest Service, and others. Participants are eligible for thousands of prizes worth a total of \$50,000 and includes cash for utility payments, water efficiency products, and a car for a chosen charity.

The online pledges received provide a national ranking for participation, and are grouped according to population. For five years in a row, Castle Rock has reached the top ten in participation with us reaching #3 in 2020. Other than increasing the chances of winning prizes, there is only bragging rights for our ranking.
