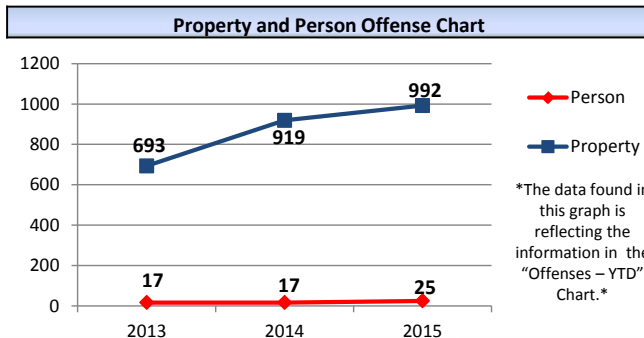

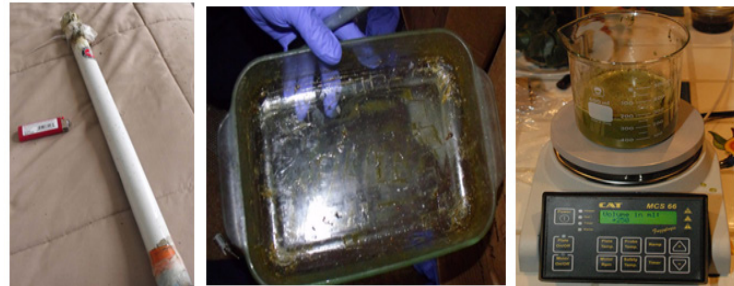
SAFETY TIP

Recently, while on a call for service at a residence, our officers located items used to manufacture butane hash oil (BHO) from marijuana. It is illegal for individuals to manufacture BHO and can be incredibly unsafe. If you see any of the below items in multiple combinations, along with a heat source such as a hot plate and glassware, please contact the Castle Rock Police Department (303-663-6100). Remember that all these items can be unsafe to handle, so use caution.

- Highly flammable liquids and gasses are used to create hash oil. These include: butane, hexane, ethanol, ether and isopropyl alcohol.
- Other items used to manufacture BHO look like everyday items but could contain chemicals that may cause an explosion.
 - Extraction tubes, propane, coffee filters, Pyrex dish, heat source (hot plate, etc.)



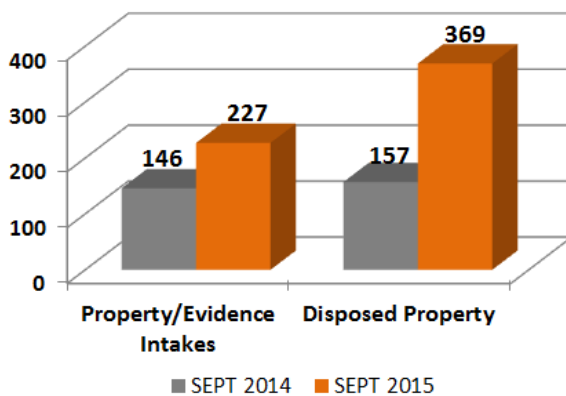
Butane is heavier than air and can stay inside the home even after the manufacturing is completed. The butane or other gases can be ignited and cause fires and/or blasts.



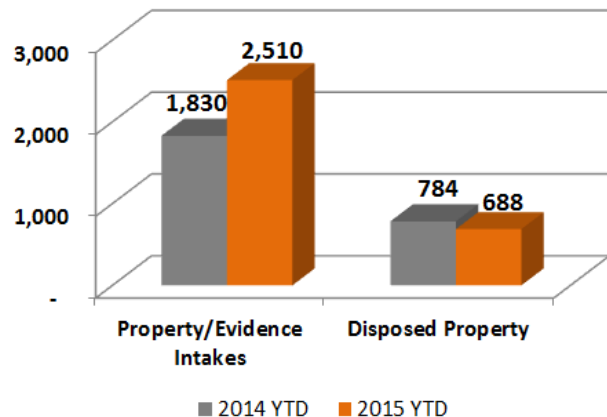
Keep in mind that while these items are flammable they also include contaminants, unsafe pesticides, concentrated versions of lubricating chemicals and harmful compounds.

Property Intakes/Disposed 2014-2015 YTD



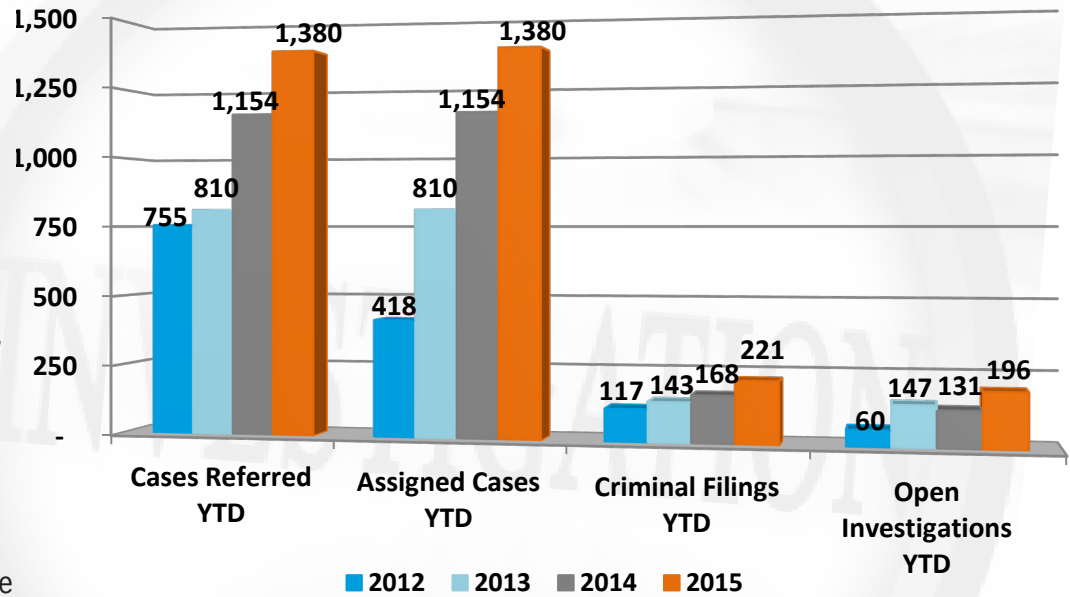

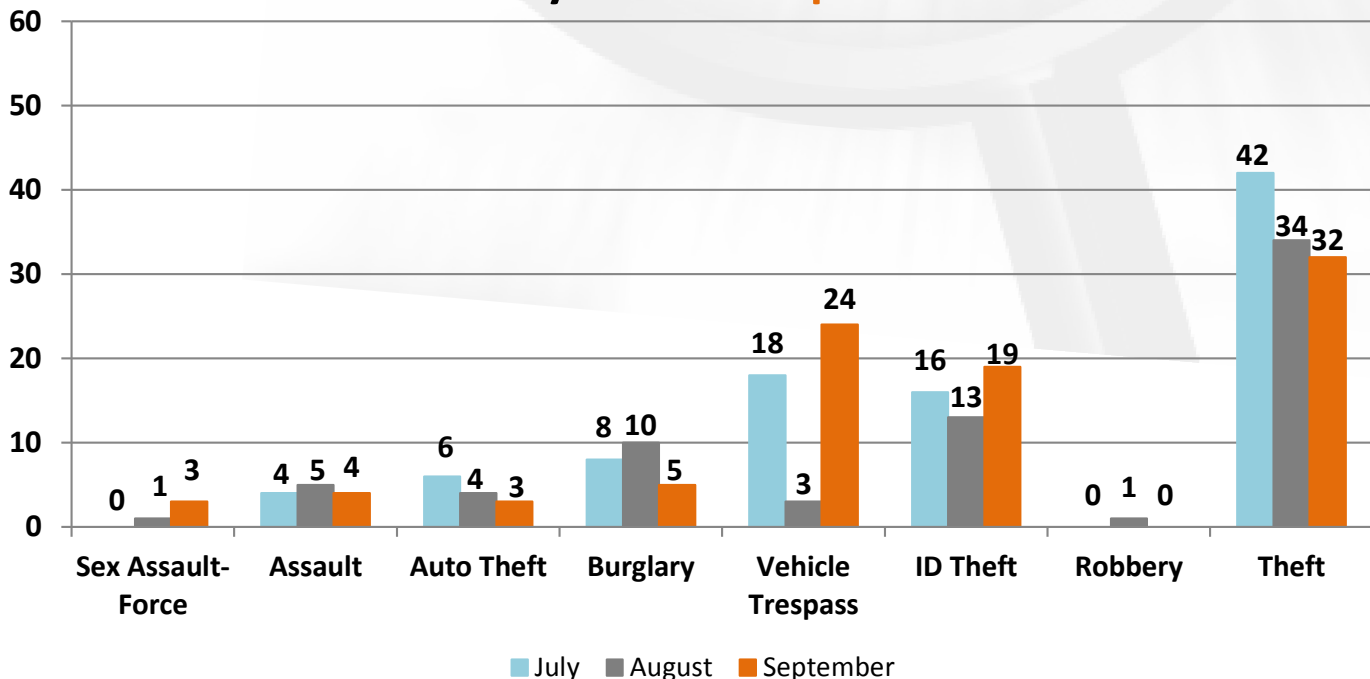
DETECTIVE UNIT

Vehicle trespasses increased significantly in Douglas County during September, and the Town of Castle Rock has not been immune. Unlocked vehicles in residential neighborhoods and apartment complexes have been targeted by one or more groups of criminals. Property stolen from vehicles has been recovered in Colorado Springs and in the Arapahoe County/Aurora area. One suspect, whose last known address was in Aurora, has been identified by fingerprints collected by officers in the Patrol Division. An application for an arrest warrant has been submitted to the District Attorney's office in that case. Additional evidence collected from targeted vehicles in Castle Rock and property recovered in Colorado Springs are being analyzed at the Crime Laboratory. Residents should always lock their cars and keep their garage doors closed both day and night to help deter these types of crimes.

VICTIMS ASSISTANCE UNIT

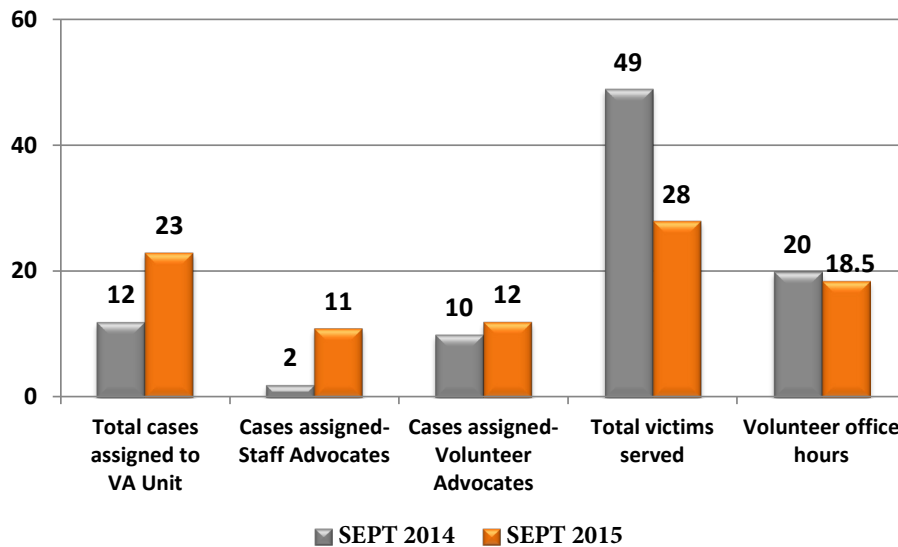

Only minor issues were found. The businesses were notified of the issues so they can resolve them prior to follow-up inspections.



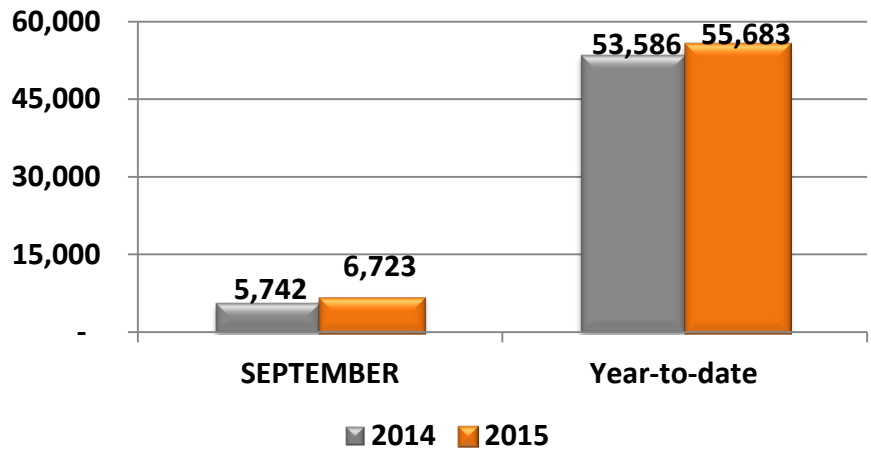

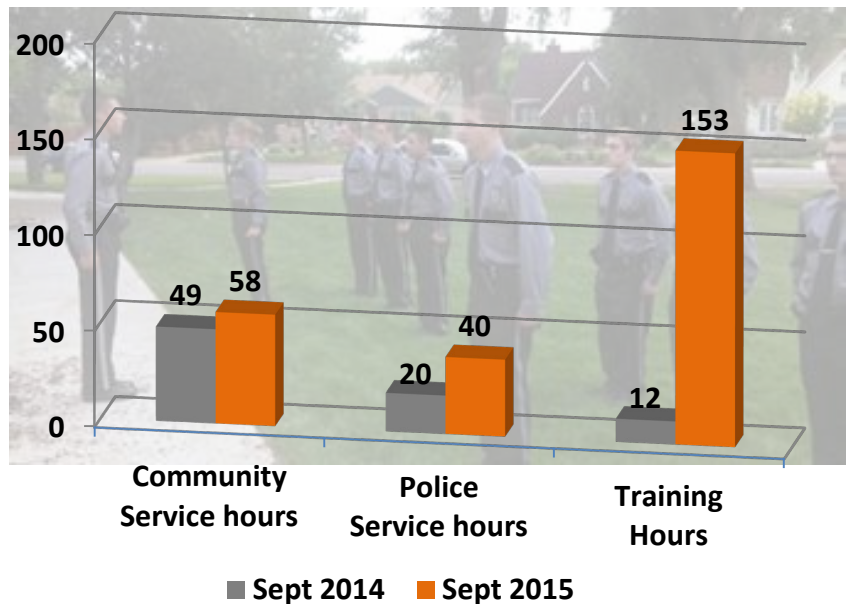

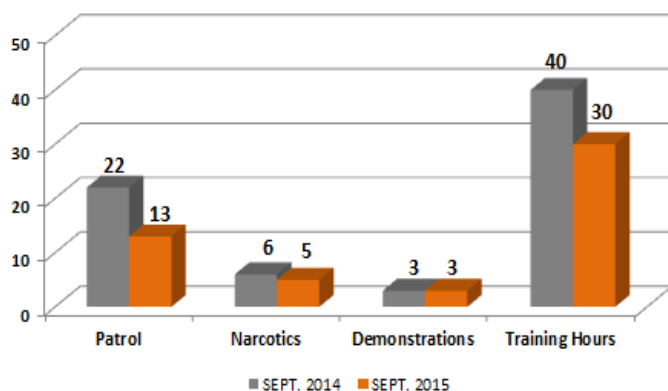

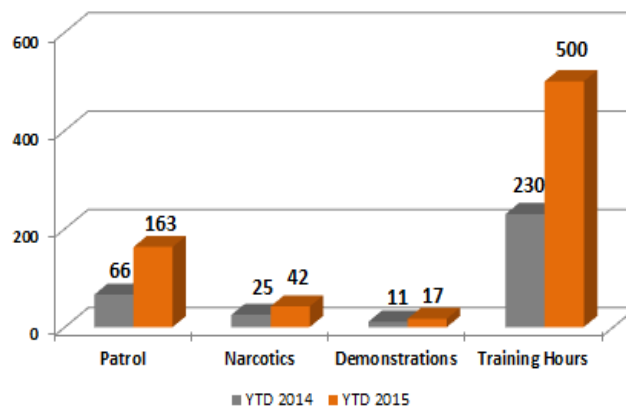

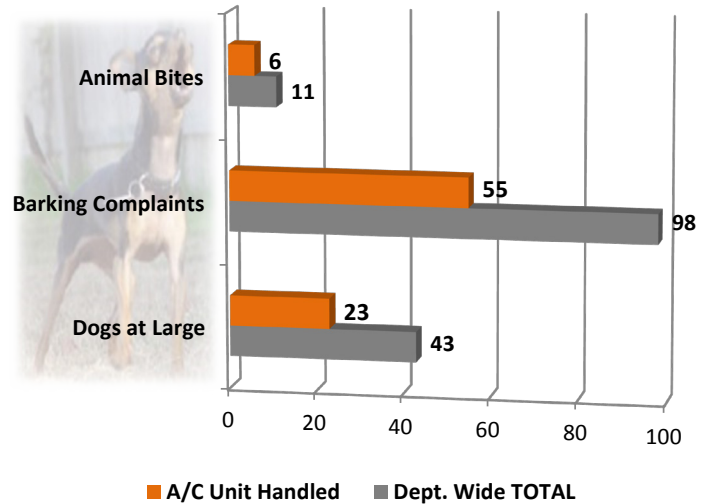

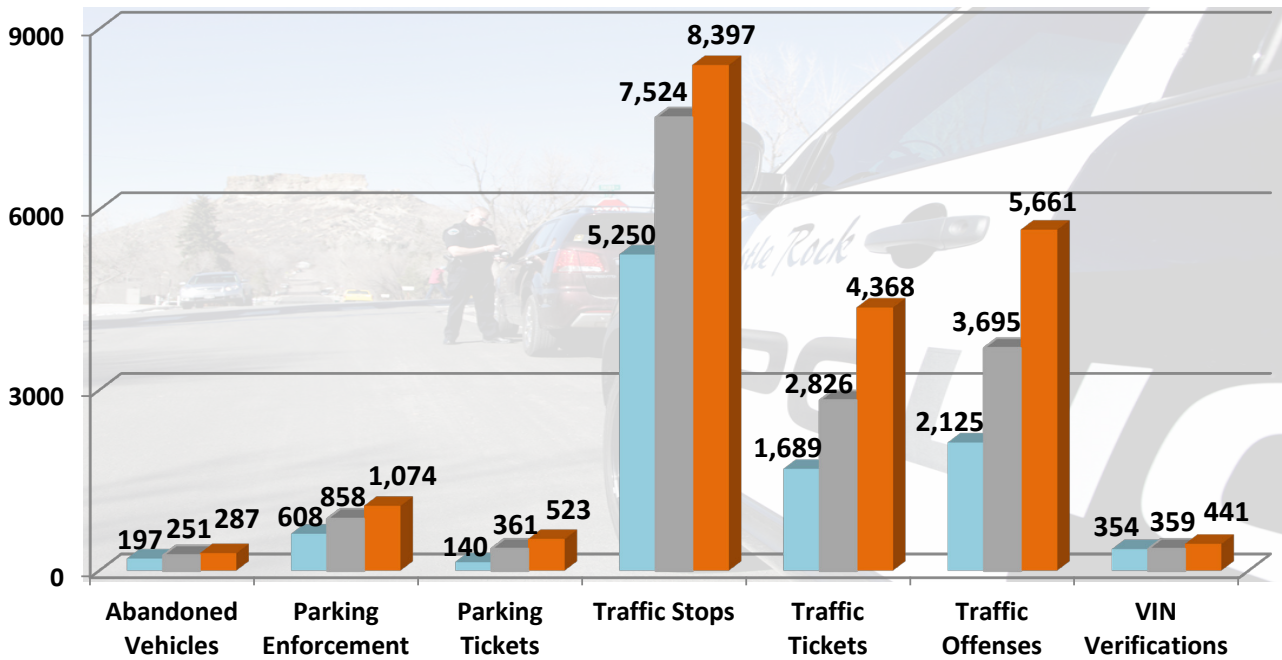

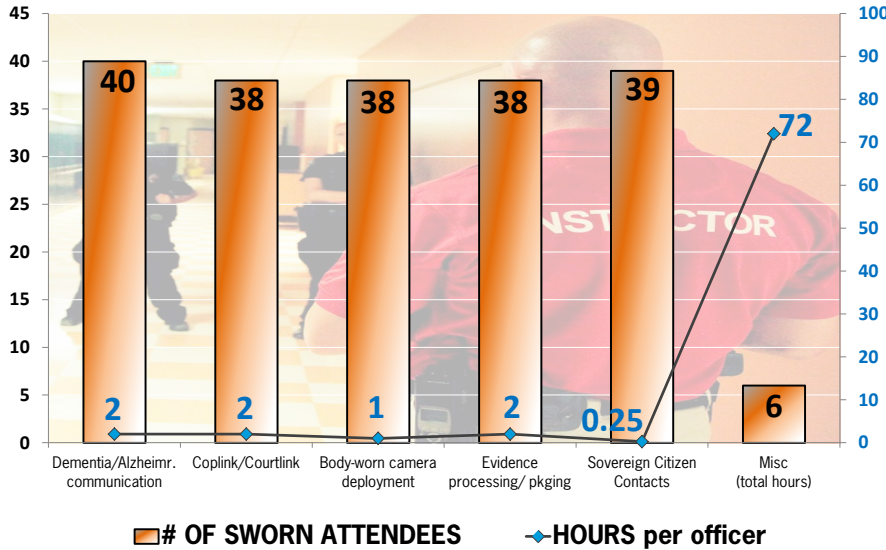

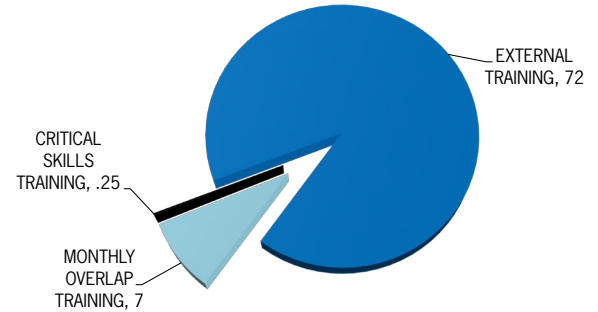

Training Hours Achieved by Category (per sworn employee)

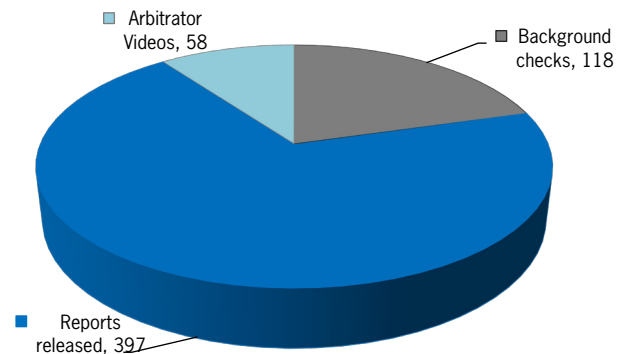
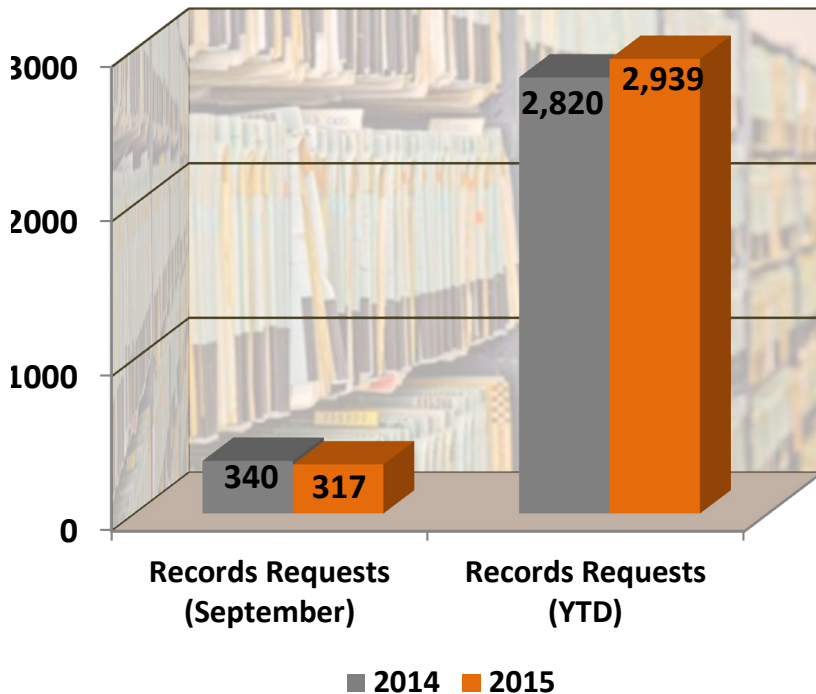


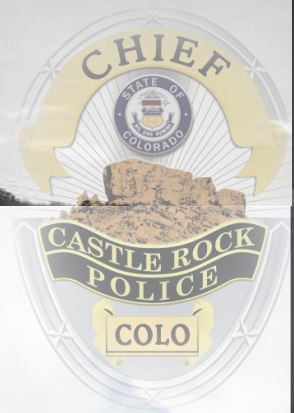
