PUBLIC ART COMMISSION SELECTION COMMITTEE

[PAC 2021-095](#) **Town Hall Plaza Sculpture: Selection Committee to Review Entries and Select Finalists**

After a jurying and ranking process was completed, the Selection Committee discussed the top-ten submissions to the call for entries for the Town Hall Plaza sculpture. Members selected three finalists who will be invited to interview and present their proposals at the regularly-scheduled January meeting where the committee hopes to make a final recommendation. Each finalist will receive a stipend of \$500 for concept proposals, which may include models, maquettes, fully executed cartoons, digital simulations, etc. Once a finalist is selected, a recommendation will be made to Town Council.

The committee also discussed the need to relocate the project's installation site. While the call for entries requested sculpture submissions for the eastern and central part of the plaza, staff had been notified that the originally proposed site was located in a fire lane. A new site was suggested adjacent to Town Hall. The Commission directed staff to notify the finalists in case adjustments needed to be made to proposals.

[PAC 2021-097](#) **Staff Updates**

Staff provided the following updates:

The Rock Paint-by-number

Since 2019, the Rock Paint-by-number has been featured in Castle Rock Adventist Hospital's emergency wing entrance. Marti Jones the Volunteer Services Coordinator from the hospital recently notified staff that the piece was moved to storage due to a permanent art installation. While their staff had offered to install the piece in a new space after completion of construction, they were wondering if the Town would like to install the piece elsewhere in the interim.

In October, the Commission discussed moving the piece from the hospital to the Recreation Center, preferably near the Senior Center. Since then, however, Castle Rock Water reached out to see if they could potentially feature the piece behind the Service Desk of the Administrative Water Building. The Commission was supportive of this action so staff coordinated logistics for its temporary installation at this new location.

Painting Positivity

Councilmember Johnson read a proclamation to highlight the Painting Positivity campaign at the Dec. 7 Town Council meeting and a thank you card was mailed to Dan Toro, artist of the flower mural. Members expressed gratitude for the proclamation and the overall campaign.

Resignation

Tonya Whitehouse will be resigning from the Commission. Staff will work with the Town Manager's office to recruit a new member to fill the vacancy once the resignation is finalized.

[PAC 2021-098](#) **Public Art Planning**

Members discussed the planning session scheduled for January 2022. Ken Greenberg graciously offered to facilitate the event. Members were encouraged to brainstorm ideas for the Public Art Commission's vision statement, value statements, future goals and actionable strategies. Staff noted that they would purchase supplies for the session and that food and light refreshments available.
