The property was owned by notable historic figures who made various additions. The property was locally landmarked in 2003.

Councilmember LaFleur informed Ms. Deleo that the Town is looking into the possibility of equipping the trolley with additional visual components. Boardmember Lange provided Chair Beystehner with renderings of the building models to make copies which will be handed out during Historic Preservation Month and throughout the year.

Mr. Claussen reported on his efforts to raise the curiosity of residents, specifically children, on the history of Castle Rock. This specifically included an area hike. Mr. Claussen will schedule a hike for the Board.

Salinas questioned Mr. Boland to check into the CLG credits and the Board's standing. Salinas reached out in NPR to see if the Mr. Claussen's presentation could be made into one of their postcards.
