As sales tax returns are due 20 days after the end of the month, this report shows the prior month's revenue.

Communicating results

Sales tax collections for July were up 12.6 percent from the previous year's month, or up \$702,860 compared to July 2021. Year-to-date (YTD) collections are up 12.0 percent compared to the same time frame in 2021. Staff will continue to monitor this very important revenue stream for the Town and inform as needed.
