Description of organization:	A Precious Child is more than a Resource Center; it is a one-stop shop for families in crisis to receive the goods, opportunities and resources they need, including financial housing assistance. These additional resources provide more than a bandage of services; they provide the foundation families require to become empowered to achieve their full potential, for children to grow up to be a secure, self-reliant, contributing member of their community. Fortunately, breaking the poverty cycle is possible when families can access the resources and support they need. Since 2008, A Precious Child has aided more than 405,000 children throughout the Denver Metro eight-county area, helping families begin the path to becoming self-sustaining and end multigenerational poverty. Through five Cradle to Career Initiatives and eleven programs, A Precious Child provides basic essentials to children challenged by poverty, abuse, neglect, or crisis situations with resource navigation and case management services, as well as basic essentials including clothing, diapers, formula, coats, food, shoes, hygiene items, school supplies, gifts for the holidays, mentoring, workforce development,	

educational opportunities and access to extracurricular activities that are often not available to children faced with their family's economic hardship and other difficult life challenges. In 2021, A Precious Child provided 48,514 economically disadvantaged children with basic essentials alongside 6,015 of their caregivers who received wrap-around services such as translation services, housing opportunities, shelter assistance, food pantry access, and detailed case management services with referrals to the community. A Precious Child works to ensure children have community-based support to end multigenerational poverty; these include the Precious Mentor program, the Precious Perks Social- Enterprise Workforce program and our Financial Housing Assistance opportunity.

Our vision is that all students will have the clothing they need to feel comfortable, confident and prepared to thrive.	
	CTKD proudly provides free school clothing and a shopping experience for students in need throughout the 11-county Denver Metro Area. Central to the CTKD mission is our boutique, a 3,000 square foot space where student shoppers are invited to browse our wide selection of clothing for a 21-23 piece school wardrobe, which includes five outfits, new underwear, new socks, a bra, shoes and a coat. Shoppers are also encouraged to take home extra items, which may include winter items, accessories, sports equipment, toys, toiletries, books and school supplies. In addition to shopping in person, students can now use Curbside Service, which was created in response to the COVID-19 pandemic and allows wardrobe requests to be submitted by phone or email for contactless

pick-up. No matter how they choose to shop, students are invited to select a wardrobe every 4 months.

CTKD's attractive store-like setting combined with our emphasis on providing shoppers with the best quality, selection and customer experience possible make CTKD the preeminent clothing resource for students in need in the 11 county Metro Denver. In this time of tremendous hardship for so many, CTKD has continued to meet a pressing need and serve as a nurturing, happy place for children and youth in our community. The clothing we provide not only removes a barrier to school attendance, participation and achievement for our students, but also frees up funds families can devote to other necessities, such as medical care, bills, groceries and rent. CTKD has built a strong reputation among hundreds of schools, agencies and faith-based communities across the Denver Metro Area, which have come to rely on CTKD to meet the clothing needs of students from low-income families.

As of July 31, 2022, CTKD has provided a fun shopping experience in a boutique environment to 86,262 students since September 2008. In 2021 alone, CTKD distributed 9,150 wardrobes and 22,541 pounds of extra items, with 93 percent of shoppers selecting a complete wardrobe (all 21 non-optional pieces).

Description of specific project for requested funds:

We are seeking support from the Town of Castle Rock for our "Underwrite Our Underwear!" initiative. Demand for new socks and underwear at CTKD is at an all-time high due to our continued growth. Individuals and community groups donate the majority of the inventory available to our shoppers, but undergarments remain notoriously difficult to obtain in that manner since they must be new. CTKD has negotiated bulk discounts on these important basics and has reached out to

donors for contributions through our annual "Undie 500" drive and "Socks in the City" campaign, yet still spends thousands of dollars each year to meet the need for these items. A grant of \$500 from the Town of Castle Rock will provide new undergarments for nearly 100 students*. This gift would make a huge impact considering that CTKD currently serves an average of 834 shoppers per month and anticipates providing approximately 10,500 wardrobes in 2022. CTKD's 2022 budget for these items is \$55,000. *CTKD's current cost to provide 5 pairs each of new socks and new underwear is \$5.59/student.

The students who shop at CTKD are experiencing some of the most difficult circumstances imaginable – poverty, homelessness, displacement and home removal. CTKD has built a strong reputation among hundreds of schools, human service agencies and faith-based communities across the Denver Metro Area, which have come to rely on CTKD to meet the clothing needs of students. New socks and new underwear are the foundation of the wardrobe that we provide at CTKD:

Last fall, I attended a back-to-school event in Douglas County. The event is targeted towards middle and high school students from low-income families who are considered at risk of dropping out of school. At the event, a 7th grade boy casually walked past our booth a few times before stopping to say quietly to me, "Everything I'm wearing I got at your store." Then he smiled and said, "And I mean EVERYTHING, even my socks and shoes. I get to come back next month to shop again!" His outfit was very sharp and you could tell he felt truly confident. I asked him how he was doing in school and he said his teacher had recently told him that he was "really turning things around this year." It was so exciting to see that shopping at CTKD had helped this student put his best foot forward.

Since January 2021, CTKD has been administering an ongoing survey designed to collect data about customer satisfaction, customer experience and the quality of the shopping experience we provide. Results of the customer survey described above were very favorable, with 86 percent of respondents saying that CTKD was "Much Better Than" or "The Best" compared to other clothing resources. A majority of respondents (94 percent) "Strongly Agreed" that they were treated with respect during their visit. 91 percent said they would "Strongly Recommend" shopping at CTKD to their friends and family members. Also notable, 94 percent of respondents "Agreed" or "Strongly Agreed" that their child found clothes that he/she likes wearing at CTKD, and 92 percent "Strongly Agreed" that volunteers and staff provided them with good customer service during their visit. Full survey results are available upon request.

CTKD was fortunate to receive funding from the Town of Castle Rock in 2017, 2018, 2020 and 2021. This funding has enabled CTKD to create additional appointments for shoppers and grow its both its paid and volunteer staff. With your continued support, we will be able to keep expanding our reach and serve even more students in 2022.
