- Coordinated effort with Police, Municipal Court and Facilities departments to improve the facility as efficiently as possible
- Maximize unused Police Department space to accommodate additional staffing
- Courtroom, public restroom and other ADA improvements

IMPROVEMENT OVERVIEW

Basement Improvements

- Convert old evidence room to expanded locker room facilities – increase of 58 men's lockers (140 total)
- Renovate old locker room facilities increase of 34 women's lockers (52 total)
- Expand fitness space
- Repurpose sally port and holding cell areas add 62 load-out lockers
- Repurpose space to add two quiet rooms to benefit officer wellness
- Additional restroom

First Floor Improvements

- Expand public restroom facilities to ensure proper ADA accessibility
- Relocate one prosecutor office (due to restroom expansion)
- Addition of courtroom vestibule to reduce noise intrusion from lobby
- Courtroom ADA improvements including judge's dais and jury box areas
- Accessibility improvements to women's restroom in secured area

Budget:

- \$2,000,000 of 2021 TABOR surplus funds approved for this use in July 2022 and appropriated as part of 2nd Budget Amendment in August 2022
- Project funding request:

Construction Contract	\$ 1,778,493
Contingency	\$ 177,849
Total Authorization	\$ 1,956,342

 Additional expenditures for materials testing, furniture, fixtures and equipment outside of this contract

RECOMMENDATION

- Staff recommends approval of a construction contract with MW Golden Constructors for Police Department improvements
- Logistical planning following Council approval (building security, project phasing, etc.)
- Construction estimated to take approximately seven months
- Improvements result in ADA accessible facility that will accommodate Patrol officer needs for the next 10-15 years
