#### [PAC 2022 -047](#) **Approval of the Minutes of the September 8 and 27, 2022 Public Art Commission Meetings**

#### [PAC 2022 -048](#) **Staff Updates**

Staff provided the following updates:

##### **Castle Rock Fire Department Watercolor Painting**

The painting was received by Town Staff and also featured at Councilmember LaFleur's open house at Festival Park. Desiree is currently brainstorming unveiling ideas to honor the Fire Department and feature the piece at a future event in summer 2023.

Member Ann O'Leary suggested placing the painting at Town Hall. Chair Jen Perry noted that wherever the piece goes, it should be featured in a humidity controlled environment, outside of direct light, as well as accessible to the public.

**Pedestal at Butterfield Crossing Park**

As renovation work continues at Butterfield Crossing Park in The Meadows, the art pedestal had been set at its new location; staff showed members photos.

**Still Wild**

Staff held an on-site meeting with artist Amie Jacobsen, an electrician and concrete contractor to plan the foundation prep required for the commissioned sculpture, Still Wild, near Town Hall in the plaza. The artist provided the unfortunate update that the sculpture will not be ready until January 2023 at the earliest. Foundation prep will still continue this fall to ensure the site is ready for the soonest installation possible.

Members debriefed their attendance at the Castle Rock Artfest, overall indicating that the rock painting activity was very successful.

[PAC 2022 -050](#) **Call for Entries for Parking Garage Banner Art**

The Public Art Commission subcommittee recommended two proposals receive awards from the Call for Entries for parking garage banner designs. Samantha Wood asked when the banners would be featured and advised letting the artists know which art would be featured when. Jen suggested featuring the hummingbirds in the spring and summer seasons, whereas the Castle Rock artists' compilation would fit better in the colder months. Staff will pass along this feedback and work with the artists to finalize the designs. It was indicated in the selection meeting that the parking symbol should be featured but not necessarily the words "Castle Rock." Chair Jen Perry motioned and Ann O'Leary seconded the selection of Various Castle Rock Artists and Talia Johns' Hummingbirds.

The purpose of this agenda item was to discuss and determine the deaccessioning process and next steps for Tribal Jam, the public art sculpture installed near the skate park at Metzler Ranch Community Park. After reviewing the commissioned artwork's original contract and the proposed process, it was determined to notify the artist to respectfully inform them of the Town's decision, complete public outreach by posting signs on site leading up to the removal and distribute a memo or notice through the Town Manager's office to inform leadership and Town Council of the process and timeline. The memo will include background information, a summary of the present damage and photos for documentation.
