I am a homeowner living in Timber Ridge directly backing up to Crowfoot. First off thank you for soliciting comments/feedback throughout the planning process and for your recent efforts to reduce the speed of traffic through the neighborhoods south of Sapphire Point. We greatly appreciate your willingness to include affected homeowners in the process. Being directly affected by this project please consider the following:

1. We support a dedicated left hand turn lane out of Timber Ridge and feel it is necessary in order to safely travel NB.


2. We support a traffic light at Sapphire Point to hopefully slow down speeds and create breaks in traffic to enter Crowfoot.

3. We do not support any other traffic lights or roundabouts on the hill to eliminate stop/go noise and exhaust pollution.

4. We hope consideration will be given to eliminating median light pollution on the hill affecting our residence and others.

5. We believe completion of Canyons Boulevard/Parkway? connecting Crowfoot to Hess would greatly help alleviate the speed and traffic affecting the four neighborhoods from Sapphire Point to Founders Pkwy and recommend this additional artery to access I25 be completed as soon as possible.
