Many supporters of bann ng drag shows in Cast e Rock speak about how these events contain content too graphic for children and therefore should not exist at a . Diminishing the artistic expression of others because it makes someone uncomfortable is not a precedent that should be set for how a government can dictate what type of freedom of expression is acceptable anywhere, nc ud ng n our town. It cou d be argued that tak ng a ch d to a graph c dep ct on of the torture and k ng of a man s too graph c for ch dren, but the story of the cruc fx on and resurrect on of Jesus Chr st s the most important aspect of the Chr st an fa th. Are we to ban every dep ct on of Chr st on the cross for the sake of the ch dren, too? Who gets to u t mate y dec de what is acceptable or what is too graphic for a child? This question is a difficult one to answer, and there are certainly aws n p ace to try and protect ch dren from exp c t harm, but at the end of the day no one s forc ng a parent to take the r ch d to church or to a drag show. Ne ther of these th ngs are nherent y harmfu and the dec s on to part c pate or not s persona to each fam y. We open each town counc meet ng with an invocation ed by a person of faith. They remind us that our dec s ons dur ng these meet ngs are so much b gger than us and so much more mportant than just this moment. Our values and our actions shape the society well vein and that responsiblity is not to be taken ightly.
