A. <u>A Resolution Approving the Plum Creek Ridge at Castle Rock Site</u> <u>Development Plan, Amendment No. 1</u>

(6:08 p.m.) Ferguson: The Site Development Plan proposed a total of 45 townhome units on a 3.34 acre lot. Townhomes are divided up into 10 different buildings. Site plan also incorporates lighting and landscaping.
