Home Rule Charter Amendment A: In order to implement the November 7, 2017 voter-approved amendment to the Town of Castle Rock Home Rule Charter providing for a Town Council consisting of a Mayor elected at-large and six Councilmembers elected from districts, shall the Town Charter be further amended to add a transition plan specifying the November 6, 2018 regular election as the date for election of the Mayor and two Councilmembers and the following regular election as the date for election of four Councilmembers, authorize the Election Commission to timely establish the boundaries of the six Town Council districts in 2018, and make certain other conforming amendments to the Town Charter in accordance with Town Council Ordinance No. 2018-002? Home Rule Charter Amendment B Shall Section 2-4 of the Town of Castle Rock Home Rule Charter be amended to establish qualifications for the office of Mayor such that the Mayor at the time of nomination, election or appointment is a registered elector of the Town of Castle Rock, a citizen of the United States, and a resident of the Town of Castle Rock for twelve consecutive months preceding election or appointment and prohibit the Mayor from being a paid employee of the Town, in accordance with Town Council Ordinance No. 2018-002?
