Elections



We have several candidates registered to run for Town Council in November. All registrations are linked on our website under Town Government/Elections/Financial Filings.

Petitions are currently being circulated by the candidates and are due to the Town Clerk by August 27.

After petitions are verified, the ballot order will be determined by lot.

Ballots will be mailed the week of October 15.

Election of the Mayor and Councilmembers for Districts 3 and 5 will occur on November 6, 2018 along with further Charter amendments to clean up initiative language for electing a Mayor at large.

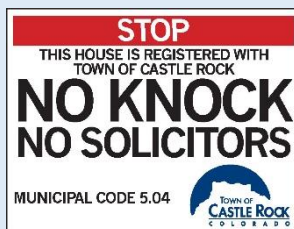
Newly elected members of Town Council sworn in on December 4, 2018.

Records

Continuing long-term process to organize, index and analyze all scanned Town records for retention requirements.

Staff continues to fill public records request under the Colorado Open Records Act. In 2017, we filled 121 CORA requests. As of July 2018, we have filled 66 in 2018.

Solicitors must register with the Town each year and may not knock on your door if you are on the No Knock list. If you are not registered, Solicitors may knock on your door; and there is currently no curfew/restriction on times that Solicitors can contact residents due to the outcome of the Aptive litigation.

No Knock stickers are mailed to the newly enrolled residents, and their addresses are added to the No Knock List which is published on the Town website.

Liquor Licensing

Liquor licensing activity has increased as the Town continues to grow and attract new establishments in addition to existing businesses changing ownership.

Current Initiatives: Propose an ordinance that will alter the 500-foot distance requirement to new schools and monitor legislation that impacts liquor laws such as full strength beer sales at previously licensed 3.2% stores beginning in 2019.
