

## Swearing-in ceremony at Town Council



On August 21, Castle Rock Teen Court's (TC) Law School class of 2018 went before Town Council and the attendees of the Council meeting. At the conclusion of these volunteers' youth attorney training, and before they begin serving as youth attorneys for TC cases, a swearing-in ceremony is conducted in front of our Mayor and Councilmembers. Each new attorney repeated the following oath as led by Nate Marsh, our TC Law School facilitator, "I do solemnly swear that as a TC attorney, I will conduct myself uprightly and according to the law. I will support the principles of restorative justice and will treat all persons I represent with respect, honesty, and fairness, using my position to fulfill the purposes of TC and benefit my community and fellow peers. " TC Law School is available for youth volunteers who have completed General Legal Training and have a desire to further their learning and develop their skills serving as either the defense or prosecution councils for TC trials. Law School requires each participant to go through six



training sessions; perform two mock trials, serving as defense and prosecution for a mock defendant; and complete a Teen Court Bar Exam. When asked why these volunteers wanted to participate in Law School, they said: "By completing law school, I will get an opportunity to do something that I am passionate about, and it will aid me in my hope and goal to become a prosecuting attorney in the future".

"It seems like a very interesting and fulfilling role that would challenge me and allow me to further develop my public speaking skills and knowledge of the law and legal proceedings".


"I want to help the defendants as they go through the TC program, and law school is another step on my journey to do so."

After the ceremony, the kids received a standing ovation from the Town Council and a "congratulations" from Mayor Green.
