ENSURING OUR PUBLIC SAFETY (**)

PD

- **IMPROVEMENTS ACCOMPLISHED; OTHER NEEDS EXIST**
 - Operate Fire Station 152 for a full year
 - Add an Operations Assistant within the Fire Department
 - Fund new auto extrication equipment, a pump-testing unit, a digital fire simulator, new data analytics software, and an update of the emergency operations center
 - Add 2 Police Dispatchers, 1 Co-Responder Officer, and 1 School Resource
 Officer to start mid-2019; Change Crime Analyst from contract to FTE
 - Not able to fund several other positions in 2019 (11 public safety FTEs req'd)

ENHANCING OUR TRANSPORTATION



STREET MAINTENANCE AND CAPACITY BUILDING REMAIN STRONG – IMPACT FEE REVENUE IS KEY

- Strong annual Pavement Maintenance Program (\$14M)
- 2019 Capital Improvement Projects:
 - Plum Creek Parkway widening between Gilbert and Eaton
 - Design work on a roundabout at Crowfoot and Timber Canyon
 - Design/construction of a roundabout at Wilcox and South St.
- Add 2 Streets Operator positions, 1 GIS Asset Management Technician,
 1 Signs and Markings Technician, and 1 Parts Clerk for Fleet

ENHANCING OUR TRANSPORTATION

SNOW REMOVAL OPERATIONAL CHANGES



- Current level of service requires a multidepartment response
- Roughly 18 lane miles per year are added to what the Town must plow
- Castle Rock Water is moving to 24/7 plant operations to meet levels of service
- Six additional drivers are needed to operate plows 24/7 (equipment available)
 - Parks: Two winter seasonal employees
 - Water: Two winter seasonal employees
 - PW: Convert two summer seasonal employees to full time
 - These positions can be used for other winter ops, like holiday lighting
 - Staff requests consensus for adding these positions before winter 2019

MAINTAINING STRONG PARKS AND RECREATION



- Replace playground equipment and complete other park improvements
- Replace cardio equipment and the HVAC unit serving the Leisure Pool at the Recreation Center
- Design the next neighborhood park, which may be in Cobblestone Ranch/Liberty Village

IMPACT FEES

- An independent study of impact fees indicates a funding gap of about 53% between present impact fee revenues and the funding needed for future growth-related projects.
- If Council intends to remain faithful to the longstanding "growth pays for growth" philosophy, impact fees will be need to be increased to maintain levels of service as we add 2,000+ residents per year to our community.
- Staff is not recommending immediate adoption of EPS' maximum supportable fees, but rather a four-year phase-in 15% the first year, 11.7% plus inflation in the second and third years and 7% plus inflation in year four.

For 2019, this would represent a .37% increase on a home valued at \$450K

IMPACT FEES

- The recommended fees would allow the Town to construct additional roads, parks and other facilities to help keep pace with growth
 - This approach would provide funding for another fire station in 10-11 years; current impact fees would not support construction in that timeframe (\$1.1M additional revenue est. 2019-2023)


TRANSPORTATION IMPACT FEE

\$9.5M additional capital revenue est. 2019-23 would advance these projects:

TRANSPORTATION IMPACT FEE

Even with the additional capital revenue, challenges would remain, including having a viable financing plan for the I-25/Crystal Valley Parkway interchange, if development is not on track in the area to contribute its share to the project



PARKS AND REC IMPACT FEE

\$8.9M additional capital revenue est. 2019-2023 would allow for construction of a new park every two to three years, as well as for accumulation of funding to construct a new indoor recreation facility in the next decade

The next neighborhood parks are slated for these areas:

- Castlewood Ranch, near Flagstone Elementary School
- Cobblestone Ranch/Liberty Village, near the neighborhood pool
- Crystal Valley, at the south end of Loop Road
- Terrain, near the neighborhood pool and dog park

A study is planned for 2019 to identify indoor recreation facility needs and potential locations

MANAGING TOWN FINANCES CONSERVATIVELY




- Add a 3/4-time Sales Tax Auditor position
- Fund employee compensation at an average 3.5 percent performance-based increase for general employees, with an average of 4 percent budgeted for sworn public safety personnel; also, budget for Town health premium increases at 8 percent, with a corresponding employee match

BUDGET DEVELOPMENT PROCESS

- Presentation of the Proposed 2019 Budget and impact fees on August 21
- Presentation of the annual water rates and fees study also on August 21
- First reading of the budget ordinance is planned for September 4
- Second and final reading is planned for September 18
- First reading of the property tax mill levy ordinance also is planned for September 18, along with adoption of the 2019-2021 Balanced Financial Plan and the 2019-2023 Capital Improvement resolutions
- Second and final reading of the property tax mill levy ordinance is planned for December 4

The planned schedule leaves time for addressing any new issues that might arise during the course of the financial planning process.
