**SOURCE OF ACTIVITY/BACKGROUND:**

On September 26th, 2018 at about 12:06 P.M., I, Castle Rock Police Officer Brian Finley, responded to 4175 Trail Boss Drive, Town of Castle Rock, County of Douglas, and State of Colorado, on a reported damaged piece of artwork. I was advised this damage took place sometime around September 18th, 2018.

**OFFICER OBSERVATION/INVESTIGATION:**

Upon arrival, I spoke with a male identified as Tim Squibb DOB 01/15/1978. Tim is an employee with the Town of Castle Rock. He advised on September 18th, 2018, he observed a damaged piece of artwork located near the play ground. It appeared to Tim that the damage was caused by a blunt object.

On this date, Tim arrived back at the piece of artwork and noted the damage had already been repaired. Tim is unaware of the cost associated for the repair.

Tim emailed me pictures of the initial damage to the piece of artwork.

There are no surveillance cameras in the area to help with identifying a suspect.

There is no known suspect information available.
