Bill Detweiler, Director of Development Services presented the item to Council.

Applicant R C Hannish presented an overview of changes made to the Site Development Plan after meeting with neighboring residents.

Citizens that addressed Council:

Vickie Deppe, resident, voiced a concern over adequate parking and the effect on the surrounding neighborhoods.

Jim Deppe, resident, appreciates the changes but wants to see lower density.

Joseph Murin, resident, backs up to the proposed development and would like it to be more compatible.

Rob Meissner, resident, feels the area is crowded and is concerned with water pressure. He would like to see single-family detached and would like the concrete

swell buried.

Bill Lloyd, resident, is concerned with traffic congestion with already having 6 stoplights and a railroad overpass in the area.

The applicant addressed some of the comments. Half of the units have a shared drive with two-car garages and space to park another vehicle in front of the garage. They are working with storm water to bury the concrete swale. They lowered the grading by 5 feet and restrict lots 1-8 to single story homes.

Councilmember Loban asked if there is access between the two neighborhoods. The applicant stated there is no vehicular connection.

Councilmember Bracken confirmed that they are targeting senior aged residents but there is not an age restriction. Bracken prefers single family homes, but they have met all the requirements.

Councilmember Johnson stated that Castle Rock Development made alot of accommodations to work with the residents.

Mayor Gray commended all involved and that noone got exactly what they wanted, but they arrived at a compromise.

# ORD 2019-004 Ordinance Amending Sections 8.24.020 and 8.26.040 of the Castle Rock Municipal Code Concerning Fireworks (First Reading)

Britton Cottrell, fireworks retailer commented on the impact to their business, that they sell "safe and sane" legal fireworks, and would like to meet with the Town to come up with a solution.

Garrett Mackay, fireworks industry representative stated their safe and sane fireworks are designed to be safe under any conditions if used properly.

Brad Witherell, fireworks retailer commented that the danger arises for use of illegal fireworks and this ordinance would put them in violation if they were storing fireworks during a stage 1 ban.

Townsend moved, seconded by Bower, that Ordinance No. 2019-004 be Tabled indefinately. The motion passed by the following vote:
