## **TOWN COUNCIL UPDATE**

(6:02) Mayor Pro-Tem Bower presented that the Town is conducting several open houses to inform residents and solicit feedback. On April 4, the open house will be regarding Kratom, which is an herb (not cannabis) that is an unregulated herbal supplement. The Town had received an application to open a Kratom cafe and decided additional information was needed before going forward. The Town will

also listen to resident's opinions about allowing ducks, mini goats and mini pigs in Town limits at an open house on April 9. Both open houses will be at Town Hall.

Regarding both Riverwalk properties, the proposed facade changes were presented and staff recommends approval with the condition of the stucco-painting.

Tony DeSimone with Riverwalk and Dan Crain with Crain Architecture provided further explanation on the proposed changes. They also informed the commission that Glacier Ice Cream will open this week and that on April 1, the first residential tenants will be moving in.

Councilmember Bower asked the applicant if they were open to adding artwork or a mural on the retaining wall along the trail. Riverwalk confirmed they were looking into options for this.

Chalian moved to approve this Riverwalk Site Development Plan Amendment as shown with the following conditions: Add the stucco-like paint to the smooth concrete retaining wall on Riveralk South as shown in Attachment B. With a second by LaFleur, the motion passed.
