

Summary

The Town Clerk and Legal department are working on the **Festival Park Commons General Improvement District** items, bringing an Ordinance Accepting the Petition to Include the third parcel into the GID and Resolutions for posting of public notices, approving the Encore Redevelopment and Financing Agreement, and Calling the Election to increase the property tax mill levy from 30 to 45 mills. The Town Clerk's Office will be conducting the election.

The Town Clerk is part of the **Special District Review Team** that evaluates the Metro District Annual Reports which are due on September 1 each year and reviews applications for quinquennial findings.

The **Election Commission** had its first meeting on August 21st. There are no requirements of the Commission until the 2021 Redistricting, so the Commissioners have elected to do a review of the Election Commission Regulations, the Town Code and Town Charter for any recommended or needed revisions in regards to election matters.

There has been a **278% increase in CORA** open records requests. These requests take a substantial amount of time from the Clerk's Office and departments coordinating and reviewing these documents.

There is a slight elevation of a **12% increase in documents processed** which requires reviewing, routing for approval, executing, and archiving.

We have seen a **decrease in new and transfers of liquor licenses** this year from 16 in 2018 to 10 in 2019. There may still be applications that come in before year-end, but none that we have seen to date.

The Town Clerk sits on the **Special Events Committee** comprised of staff from Parks, Police, Fire, and Public Works to coordinate support and safety of all events held in the Town of Castle Rock. Special Event liquor permits are reduced by 29%; however, the Town increased their number of permits from 2018. We only expect 2-4 more permits this year.


