AN ORDINANCE APPROVING THE THIRD AMENDMENT TO THE 2019 BUDGET BY MAKING SUPPLEMENTAL APPROPRIATIONS FOR 2019 AND AUTHORIZING CHANGES FOR YEAR 2019

WHEREAS by Ordinance No. 2018-029 revenues and expenditures for the year 2019 were budgeted and appropriated,

WHEREAS by Ordinance No. 2019-005 the Town Council approved the First Amendment to the 2019 Budget,

WHEREAS by Ordinance No. 2019-019 the Town Council approved the Second Amendment to the 2019 Budget,

WHEREAS, supplemental appropriation of revenues is authorized under Article IX of the Castle Rock Home Rule Charter, upon certification of the Town Manager of the availability of such revenues,
