ORDINANCE NO. 2019-____

AN ORDINANCE AUTHORIZING THE ISSUANCE OF A QUITCLAIM DEED FOR THE PURPOSE OF ABANDONING THE TOWN'S INTEREST IN A SANITARY SEWER EASEMENT WITHIN LOT 3 BLOCK 1 CASTLE ROCK FACTORY SHOPS

WHEREAS, an easement was granted to the Town for a sanitary sewer line as part of the development of the Castle Rock Factory Shops by plat recorded in the public records of Douglas County at Reception No. 9213910 ("Easement");

WHEREAS, the property owner, Craig Realty Group – Castle Rock, LLC desires to construct an expansion to the existing Factory Shops and in order to do so, a portion of the sanitary sewer line located within the Easement must be relocated;

WHEREAS, as a condition to the Town's abandonment of the portion of the Easement, the property owner, at its expense, shall relocate the sanitary sewer line and grant to Town a permanent easement for the relocated sanitary sewer line.

NOW, THEREFORE, IT IS ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:

- **Section 1.** Abandonment. The Town of Castle Rock hereby abandons its interest in that portion of the Easement described in the attached *Exhibit 1*. The Mayor and other proper officials of the Town of Castle Rock are hereby authorized to execute the quitclaim deed described in the attached *Exhibit 2* on behalf of the Town of Castle Rock, Colorado. Recordation of the quitclaim deed is conditioned on the relocation of the sanitary sewer line and concurrent grant of a permanent easement for that portion of the sanitary sewer line relocated.
- **Section 2.** Severability. If any clause, sentence, paragraph, or part of this ordinance or the application thereof to any person or circumstances shall for any reason be adjudged by a court of competent jurisdiction invalid, such judgment shall not affect the remaining provisions of this ordinance.
- **Section 3.** <u>Safety Clause.</u> The Town Council finds and declares that this ordinance is promulgated and adopted for the public health, safety and welfare and this ordinance bears a rational relation to the legislative object sought to be obtained.
