## MINUTES OF THE REGULAR MEETING

## PARKS AND RECREATION DEPARTMENT COMMENTS

Director of Parks and Recreation, Jeff Brauer, provided the following updates to Parks and Recreation Commission members and staff:

Town Council approved the master plan and the subsequent first amendment to the services agreement with Norris Design for the planning and design of phase 1 of Castle Rock's next neighborhood park in Cobblestone Ranch. Staff will soon be busy pushing the project forward and will engage the public to obtain additional input for the design of the first phase.

Town Council also received an update regarding the recreation facility feasibility study, which resulted in a positive discussion. While this study will be initiated in the beginning of 2020, it will likely take up to a year or longer to complete given the nature of engaging the public, various stakeholders and staff time and effort.

Another item the Commission can anticipate hearing more about in the upcoming year is the Department's efforts in seeking reaccreditation through the Commission for Accreditation of Park and Recreation Agencies. A site visit will be held the week of Memorial Day and visitors will review documentation for all standards. The Department will receive final acceptance and recognition in October at the national conference.

Today, staff hosted a holiday party at the Millhouse with lunch and a gift exchange to celebrate the successful year and very dedicated team. It was brought to the attention of staff that they had collectively received 46 value and vision awards from the Town Manager's office in recognition of excellent teamwork, performance and commitment to Town values. The Department also received 12 national and statewide awards, including five of Colorado Community Media's Best of the Best categories:

- Best Family Entertainment Center The Miller Activity Complex
- Best Swimming Pool Castle Rock Recreation Center pool
- Best Live Music Venue The Amphitheater at Philip S. Miller Park
- Best Park Philip S. Miller Park
- Best Hiking and Biking Trail Ridgeline Open Space (Stewart Trail)

The Public Art Commission's commissioned sculpture, Tree of Wings, was installed at Philip S. Miller Park. The sculpture adds a nice color and kinetic quality to the space.

Christmas tree recycling will be available from December 26 through January 31 at Founders, Metzler Ranch and Paintbrush parks, along with the Douglas County Fairgrounds. It is required that people remove ornaments and lights prior to recycling.

The 9Health Fair will be returning to the Recreation Center on Friday, April 24 after being hosted at the hospital the last several years. The well-attended event will not only bring positive attention to the facility, but will provide convenient access to those who need health screenings and education on specific topics.

Jennifer Martin thanked Commission members for their service and attending all of the ground breakings, grand openings and wonderful community events throughout the year.

Jeff Smullen also thanked the Commission and noted that it was nice to see folks at the Reindeer Games event. Staff went through nearly 1,000 s'mores within the first 45 minutes of the event and staff did an extraordinary job of getting into character.

Sarah Grider noted that she and her family really enjoyed Reindeer Games and that it was nice to meet the donkeys and introduce her newborn to Santa.

Brian Glotzbach commented that he likes the newly installed signage at Native Legend trailhead.

Inger Hiller also thanked staff for their work and appreciates everyone's time and energy.
