**Goal:** To keep the public informed of the construction on Plum Creek Parkway, including interruptions to traffic flow and project progress.

**Background:** As part of its Transportation Master Plan, the Town is investing in the widening of Plum Creek Parkway, between Gilbert and Eaton Streets. The project will add two new lanes, one in each direction, and two roundabouts. The existing pavement between Gilbert and Eaton streets will also be reconstructed.

Phase 1B will be a continuation of the storm sewer work completed in phase 1A. The work includes installation of new storm sewer pipe, drainage inlets and manholes, constructing roundabouts at Gilbert and Eaton, constructing two new east bound lanes, and replacing the pavement on the existing lanes between Gilbert and Eaton. There will also be new sidewalk placed along the south side of the roadway with Rapid Flashing Beacons at all pedestrian crossings.

The Phase 1B construction cost has been included in the Plum Creek Widening Project 2020 budget and totals \$6,817,147.

- Castle Rock is planning for the future. Planned road improvements maintain the safety and efficiency of Castle Rock's road network as the Town grows.
- As part of its Transportation Master Plan, Castle Rock will be investing in the widening of Plum Creek Parkway between Gilbert and Eaton Streets.
- Improvements include:
  - Widening of Plum Creek Parkway between Gilbert Street and Eaton Streets.
  - Gilbert Street roundabout and Eaton Street roundabout.
  - Addition of bike lanes
  - Rapid Flashing Beacons to aid in pedestrian and driver safety
  - New sidewalk

- March 16, 2020 – Staff expected to issue Notice to Proceed with a 120 calendar-day contract
- October 27, 2020 – Estimated Phase 1B completion date
