Budget

The Accounting team undergoes the significant process of gathering data and information for their 2019 Comprehensive Annual Financial Report (CAFR), The CAFR is an audited document prepared in accordance with Generally **Accepted Accounting Principles** (GAAP). The CAFR must include the Town's component units, present individual funds in greater detail, and fully disclose all material events, both financial and nonfinancial. The team will submit the document to the state and the Government Finance Officers Association (GFOA) for review, end of June. The team also has the Popular Annual Financial Report (PAFR), the overview version for the public, in process.






