

ALEXANDER PLACE ANNEXATION BACKGROUND

- 1. Petition accepted & filed with the Town Clerk on May 12, 2016.
- 2. Substantial Compliance hearing on June 14, 2016.
- 3. Eligibility hearing on July 19, 2016.
- 4. Planning Commission recommended approval of the Annexation and Planned Development Plan on March 12, 2020.
- 5. Town Council approved Annexation, 1st reading on April 21, 2020.



PLANNED DEVELOPMENT PLAN & PD ZONING REGULATIONS


Age Restricted, 55+ yrs

FINDINGS FOR ANNEXATION

The application meets criteria outlined in the Town's 2030 Comprehensive Master Plan Responsible Growth Principles for annexation areas.

- a. The area is a logical infill of Town boundaries.
- b. The proposed senior housing use is a demonstrated significant benefit to the Town.
- c. The project will be provided with adequate urban services.
- d. The project is fiscally responsible for all of it's on site and off site infrastructure needs.
- e. The owner will convey all ground water rights at time of annexation to the Town.



FINDINGS FOR PD PLAN & ZONING REGULATIONS

The proposed plan meets criteria outlined in Section 17.34.030 of the Town Code related to:

- Community vision/land use entitlements.
- Relationship to surrounding area.
- Circulation and connectivity.
- Service, phasing and off-site impacts.
- Open space, public lands and recreation amenities
- Preservation of natural features.



DEVELOPMENT AGREEMENT

The Development Agreement requires:

- Infrastructure improvements, financial contributions, ROW.
- Public land financial contribution.
- Water dedication, financial contributions, water efficiency plan.
- Development Suspension clause, Dec. 31, 2030.

In return, the Town agrees to provide municipal services, access to parks and recreation, transportation and street maintenance, fire & police protection services, and to process development of the property in accordance with Town Regulations and approved Zoning.

RECOMMENDATION

- Council voted 7-0 to approve Annexation and Planned Development Plan and Zoning Regulations on first reading.
- Staff recommends approval of the Development Agreement.
