- Commander Lyons discussed January's monthly report.
  - Update provided on the burglary spree
    - Suspect entered various Promenade businesses posing as a fire inspector.
    - With a sufficient amount of evidence, the suspect was identified and arrested.
    - The suspect is tied to 14 counts of criminal impersonation and other cases as well as similar events in Lakewood.
    - Surveillance equipment and social media assisted with this case.
  - Citizens' police academy is accepting applications for this year's academy - deadline is March 20.
  - Federal Bureau of Investigations National Academy Associates (FBINAA) presentation to the 279th academy class on Monday, March 2.
    - The FBINAA provides leadership curriculum for their national academy and requested Chief Cauley's presentation of the department's One-By-One Policing philosophy.
    - This philosophy is based on the concept that trust needs to be formed internally first (within an organization) prior to being demonstrated externally (into the community).

## Commissioner Comments and Questions

- Will there be a ballot question to increase public safety? Chief Martin said it's being reviewed; there is nothing official at this time. Commander Lyons stated the Town's mill levy has decreased so the question would most likely not concern this funding source.
- Questions related to the coronavirus - discussions.
  - To date, there is a 3 percent mortality rate for this new virus compared to 17 percent for the H1N1 virus.

- Contingency plans are in place for possible staff quarantines, if necessary.
  - Annual flu fatality statistics are roughly 300,000.
- What is the status of the PIO position? Commander Lyons stated there are two finalists in the testing phase.
