
# Budget planning



This graph illustrates how many business licenses are issued per month, by area.



# Communicating results

The month of April's gross sales tax collections were down 8.6 percent from the previous year's month, or down \$338,684 compared to April 2019. Year-to-date (YTD) is up 2.8 percent, mostly due to January and February of this year. Staff was anticipating April 2020 to be one of the worst sales tax months of the year, with May 2020 being a close second. March and April were generally buoyed by grocery, hardware and online store, as well as audit revenue. With retail slowly opening to the public, Staff anticipates May to be similar to April and then, barring a new spike, retail to slowly begin to return to a new normal but likely down compared to prior years. During these uncertain times, Staff closely monitors trending, including regional trends, and will update Council accordingly.
