### Revenue



# CCGP funds awarded

On June 16, Town Council awarded funds to two applicants for the 2020 Second Quarter **Council Community Grant** Program (CCGP), Douglas Land Conservancy and Lady Trailblazer Incorporated! Per Town code, the Finance Department coordinates the application process for this program funded by the Non-profit Grants account in the General Fund and makes recommendations to Council who selects recipients of the grant

funds. This program aims to support projects that contribute to Castle Rock's quality of life with emphasis on programs and activities for youth, seniors, community based environment and sustainability, and community based performing and visual arts. Douglas Land Conservancy requested funds for their educational outreach, and Lady Trailblazer, a first-time applicant, requested support for their Leadership Persistence Program for adolescent girls.

# Annual audit wraps up














### Revenue



As sales tax returns are due 20 days after the end of the month, this report shows the prior month's revenue.

# Communicating results

The month of May's gross sales tax collections were up 1.3 percent from the previous year's month. Year-to-date (YTD) is up 2.3 percent, mostly due to January and February before before the Stay-at-Home Order. Staff was anticipating April 2020 to be one of the worst sales tax months of the year, with May 2020 coming in at a close second; however, grocery, hardware and online store, as well as audit revenue, generally buoyed May, like March and April. With retail slowly opening to the public, staff anticipates similar or a bit better for June and then, barring a new spike, a slow return to a new normal but likely flat compared to 2019. During these uncertain times, staff closely monitors trending, including regional trends, and will update Council accordingly.
