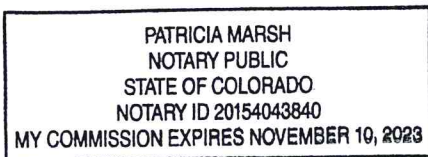

NOTICE OF PUBLIC HEARING ON SECOND AMENDMENT TO SERVICE PLAN

IN RE THE SECOND AMENDMENT TO THE AMENDED CONSOLIDATED SERVICE PLAN FOR
CRYSTAL VALLEY METROPOLITAN DISTRICT NOS. 1&2, TOWN OF CASTLE ROCK, COUNTY
OF DOUGLAS, STATE OF COLORADO

NOTICE IS HEREBY GIVEN that, pursuant to § 32-1-204(1), C.R.S., a Second Amendment to
the Amended Consolidated Service Plan (the "Service Plan") for Crystal Valley Metro-
politan District Nos. 1&2 (the "Districts") has been filed with the Town Clerk of the Town
of Castle Rock (the "Town").

A public hearing on the Service Plan will be held by the Town Council of the Town of Cas-
tle Rock (the "Town Council") on July 21, 2020 at 6:00 p.m. or as soon thereafter as the
Town Council may hear such matter. Due to the ongoing COVID-19 Pandemic, the meet-
ing is open to the public for in-person attendance and will be held in a virtual format in
accordance with the Town Council Meeting Special Procedures During Declared Disas-
ter. The public may choose to attend in person at the Town Hall Council Chambers locat-
ed at 100 N. Wilcox Street, Castle Rock, CO, or electronically or by phone. The public
hearing will be held via teleconference with advanced posting of call-in and log-in infor-
mation on the Town's website <https://crgov.com/1936/Town-Council>, and all Town
Council Meetings are also streamed online in real time at www.CRGov.com/WatchCouncil. In addition, Town Council meetings are broadcasted for Comcast
Cable subscribers on channel 22. The in person option, is subject to change, depending
on public health guidelines at the time of the hearing; the Town encourages remote par-
ticipation.

A general description of the land contained within the boundaries of the Districts is as
follows:

A portion of land being a portion of Sections 19 & 30, Township 8 South, Range 66 West,
and that portion of the Sections 23, 24, & 25 of Township 8 South, Range 67 West, both of
the 6th Principal Meridian, Town of Castle Rock, County of Douglas, State of Colorado,
containing approximately 1.495 acres.
