In order to make debt service payments and also to cover administrative costs, metropolitan districts annual certify a mill levy. This mill levy is imposed on the property owners within the given district's boundaries resulting in property tax revenue for the district. In addition, metropolitan districts are allocated a portion of the specific ownership tax each resident pays on their vehicle registration.

The following chart summaries the property tax revenue and specific ownership tax collected by each metropolitan district within the Town's boundaries.
