WHAT IS A METROPOLITAN DISTRICT?

- Taxing entity separate from the Town
- Finances public improvements that benefit property owners in the district
- Debt is repaid primarily through property taxes

THERE ARE 41 METROPOLITAN DISTRICTS IN THE TOWN, FIVE ARE CURRENTLY INACTIVE.

REVIEW OF THE 2019 METRO DISTRICT SUBMISSIONS

HIGHLIGHTS INCLUDE:

Total metro district debt is \$793M, increase of \$26.3M over 2018

- No new debt issuances
- Accumulating interest and developer advances

Of the total outstanding debt

- \$55.7M, or 7 percent, represents developer debt
- \$309.8M, or 39 percent, represents outstanding principal
- \$427.9M, or 54 percent, represents accrued interest

REVIEW OF THE 2019 METRO DISTRICT SUBMISSIONS (CONT'D)

Total property tax collected by the metro districts\$ 24,967,505Property tax collected by the Town\$ 1,483,121Town property tax as % of metro district collections6%Sales tax collected by the Town in 2019\$ 51 million

DISTRICT SPECIFIC INFORMATION NOTED IN THE STAFF REPORT

METRO DISTRICT POLICY UPDATE

PROGRESS TO DATE

- Council directed staff to form a study group to analyze metropolitan district policy and draft a sample service plan
- Internal meetings to analyze / discuss current and proposed policy considerations
 - Policy considerations could include, but are not limited to:
 - Maximum term limits on debt, not to exceed the useful life of the asset it funded
 - Cap on mill levy
 - Restrictions on subordinate debt and/or developer advances

METRO DISTRICT POLICY (CONT'D)

PROGRESS TO DATE (CONT'D)

- Policy considerations could include, but are not limited to: (cont'd)
 - Restrictions on subordinate debt and/or developer advances
 - Additional notification requirements to metropolitan district property owners
 - Regional Mill Levy dedicate to the Town for capital needs due to growth
- Preliminary draft of the service plan to Council in October, 2020
- Engaging external consultants to review the draft service plan
- Staff will bring back to Council in early 2021
